

**Norfolk County Council**  
**TEMPORARY TRAFFIC REGULATION ORDERS 2024 (NORWICH)**  
**Road Traffic Regulation Act, 1984**

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

**(i) THEY PROPOSE TO MAKE** Temporary Traffic Regulation Orders in respect of the following roads:

**HALL ROAD** - from its junction with Barrett Road for 60m northwards to facilitate the replacement of a damaged sign from 19:00 on the 22nd March to 05:00 on the 23rd March 2024. Alternative route is via: Hall Road, Mansfield Lane, Barrett Road and vice versa.

**ST MATTHEWS ROAD** - **1) St Matthews Road** from its junction with Rosary Road for 40m westwards; and **2) St Leonards Road** from its junction with Rosary Road for 30m eastwards; to facilitate UK Power Network connection works from 19th to 22nd March 2024. Alternative routes are via: 1) Rosary Road, Riverside Road and vice versa. 2) Rosary Road, Hill House Road Marion Road, St Leonards Road and vice versa.

**WILBERFORCE ROAD** - from its junction with George Fox Way to its junction with Bridge Farm Lane to facilitate telecom upgrade works from 18th to 20th March 2024. Alternative route is via: Wilberforce Road, Malbrook Road, Earlham Green Lane, Larkman Lane, Earlham Road and vice versa.

**(ii) THEY HAVE MADE** Temporary Traffic Regulation Orders in respect of the following roads:

**HIGHLAND ROAD** - from its junction with Colman Road for 10m north eastwards to facilitate access to a new utility chamber from 19:00 on the 11th March to 07:00 on the 12th March 2024. Alternative route is via: Colman Road, Muriel Road, Christchurch Road, Highland Road and vice versa.

**PEMBROKE ROAD** - from its junction with Avenue Road to its junction with Doris Road to facilitate gas main replacement works from 11th to 25th March 2024. Alternative route is via: Avenue Road, Park Lane, Doris Road and vice versa.

**WALL ROAD** - from its junction with Sprowston Road for 50m north westwards to facilitate gas main replacement works. This Order continues the provisions of the Order dated 23rd February 2024 that the road will be temporarily closed (except for access) and the restriction will now continue in effect from 9th to 15th March 2024 (previously 26th February to 8th March 2024) for the duration of the works expected to be about 7 days within the period. Alternative route is via: Sprowston Road, Chartwell Road, Constitution Hill, Wall Road and vice versa (Norwich, Sprowston).

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s). All other restrictions are included where necessary. In the event of the start date being delayed the new start date will be displayed on site in advance. Alternative routes are shown where applicable and pedestrian access will be maintained at all times. If necessary, the restrictions could run for a maximum period of 18 months from the date of the Orders or 6 months in respect of footpaths, cycle paths, bridleways, restricted byways, and byways open to all traffic (BOAT).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
