Norfolk County Council TEMPORARY TRAFFIC REGULATION ORDERS 2024 (NORWICH) Road Traffic Regulation Act, 1984

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) THEY PROPOSE TO MAKE Temporary Traffic Regulation Orders in respect of the following roads:

ELECTRIC VEHICLE CHARGING POINT INSTALLATION (2) - 1) Bury Street from 25m north west of its junction with Newmarket Street for 38m north westwards (northern side only); 2) Dereham Road from 40m east of its junction with Midland Street for 20m eastwards (northern side only); 3) Durham Street from 5m northeast of its junction with Onley Street for 20m north eastwards (southeastern side only); 4) Earlham Road from 79m east of its junction with Heigham Road for 39m eastwards (southern side only); 5) Gloucester Street from 10m southeast of its junction with Rupert Street for 22m south eastwards (north eastern side only); 6) Mill Hill Road from 170m north of its junction with Park Lane for 25m northwards (eastern side only); 7) Mount Pleasant from 10m east of its junction with Unthank Road for 20m eastwards (southern side only);); 8) Walpole Street from 36m southeast of its junction with Vauxhall Street for 58m south eastwards (north eastern side only); and 9) Portersfield Road from 5m west of its junction with Portland Street for 18m westwards (southern side only); in the CITY OF NORWICH to facilitate installation of electric vehicle charging points. This Order continues the provisions of the Order dated 9th February 2024 that traffic usings the roads will be temporarily prohibited from parking, stopping and loading/unloading vehicles and the restriction will now continue in effect from 13th April to 11th May 2024 (previously 12th February to 12th April 2024). N.B For the avoidance of doubt, 6) Midland Street and 9) Onley Street are not subject to the continuation of these restrictions.

NEWMARKET ROAD - from its junction with Elveden Close for 100m north eastwards to facilitate tree maintenance works will be subject to the temporary suspension of the bus lane between 07:30 and 16:00 from 14th April 2024 to 21st April 2024 only when signs indicating the suspension are in place expected to be for one day only.

(ii) THEY HAVE MADE Temporary Traffic Regulation Orders in respect of the following roads:

HALL ROAD – 1) Hall Road footbridge from its junction with Mansfield Lane to its junction with St Johns Close; 2) Lakenham Way cycle path from its junction with its access ramp to St Johns Close for 172m southwards; and 3) St Johns Close from 19m east of its junction with Hall Road for 11m eastwards to facilitate footway repair works. 1) and 2) will be temporarily closed and 3) will be temporarily prohibited from parking, stopping and loading/unloading vehicles from 8th to 12th April 2024. Alternative routes are via: 1) Footpath: Pedestrians will be required to use available crossing and opposite footpath. 2) Cycle path: Access ramp to St Johns Close, St Johns Close, Hall Road, Mansfield Lane, Access Ramp to Mansfield Lane and vice versa.

HEARTSEASE LANE, ST. WILLIAMS WAY, PLUMSTEAD ROAD - 1) Heartsease Lane from its junction with Plumstead Road for 50m northwards; and **2) St Williams Way** from its junction with Plumstead Road for 80m south eastwards; and **3) Plumstead Road** from its junction with Heartsease Lane for 60m south westwards to facilitate roundabout resurfacing works from 13th April to 18th May 2024. Alternative route is via: Diversions indicated by signs placed on site (Norwich, Thorpe St Andrew, Postwick and Wilton, Great and Little Plumstead, Rackheath and Sprowston).

NELSON STREET - from its junction with Dereham Road for 30m northwards to facilitate electrical link box works between 08:00 and 18:00 from 8th to 10th April 2024. Alternative route is via: Nelson Street, West End Street, Old Palace Road, Dereham Road and vice versa.

PEMBROKE ROAD - Pembroke Road from its junction with Avenue Road to its junction with Doris Road to facilitate gas main replacement works. This Order continues the provisions of the Order dated 8th March 2024 that the road will be temporarily closed (except for access) and the restriction will now continue in effect from 26th March to 12th April 2024 (previously 11th March to 25th March 2024). Alternative route is via: Avenue Road, Park Lane, Doris Road and vice versa.

QUEENS ROAD (southeast bound only) – from its junction with St Stephens Street Roundabout for 130m south eastwards to facilitate works for the bus station improvement plan between 19:00 and 06:00 from 11th to 16th April 2024 only whilst signs indicating closures are in place. Alternative route is via: St Stephens Road, Ipswich Road, Lakenham Road, Barrett Road, Martineau Lane, Bracondale and Queens Road.

SANDY LANE - from 40m west of its junction with Heartsease Road for 70m westwards to facilitate bridge inspection works between 08:00 and 14:00 on 10th April 2024. Alternative route is via: Sandy Lane, Mansfield Lane, Barrett Road, Hall Road and vice versa.

SHIPFIELD - from its junction with Sprowston Road to its junction with Brockwell Court to facilitate gas mains replacement works from 8th to 22nd April 2024. Alternative route is via: Sprowston Road, Wall Road, Clabon Road, Denton Road, Shipfield.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s). All other restrictions are included where necessary. In the event of the start date being delayed the new start date will be displayed on site in advance. Alternative routes are shown where applicable and pedestrian access will be maintained at all times. If necessary, the restrictions could run for a maximum period of 18 months from the date of the Orders or 6 months in respect of footpaths, cycle paths, bridleways, restricted byways, and byways open to all traffic (BOAT).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
