## Norfolk County Council (Norwich, Dereham Road) Emergency Notice Temporary Traffic Regulation Order 2025 Section 14(2) of the Road Traffic Regulation Act 1984

Norwich, Dereham Road (CTRO1207) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to burst water main repairs the use by vehicles (of any class) of the Dereham Road (westbound only) from its junction with Sweet Briar Road Roundabout for 200m westwards (the "Road") in the City of Norwich will be temporarily prohibited.

Alternative route is via: Dereham Road, Guardian Road, Colman Road, Mile End Road, Newmarket Road, A11 J A47 Roundabout, A11 Cringleford To Wymondham, Southern Bypass Keswick To Colney, A47 J A11/B1172 Join W, A47 Through J A11/B1172 W, A47 From J A11/B1172 To J B1108 W, A47 Through J B1108 Leave W, Southern Bypass, A47 J B1108 Join W, A47 From J B1108 To J A1074 W, A47 From J A1074 To J B1108 E, A47 J A1074 Leave W, A47 Through J A1074 W, Dereham Road. (Colney, Bawburgh, Little Melton, Cringleford, Hethersett, Ketteringham, Costessey).

The closure/restriction is necessary because of the likelihood of danger to the public or serious damage to the road or both.

The closure/restriction is anticipated to take place from 14<sup>th</sup> to 19<sup>th</sup> March 2025 but the Road may continue to be closed/restricted until the 3<sup>rd</sup> April 2025 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall automatically revoke on the completion of the works / when the closure/restriction is no longer necessary or otherwise on the 3<sup>rd</sup> April 2025 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

The works promoter for this restriction/closure is: Anglian Water.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
