## Norfolk County Council TEMPORARY TRAFFIC REGULATION ORDERS 2025 (NORWICH) Road Traffic Regulation Act, 1984

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) THEY PROPOSE TO MAKE Temporary Traffic Regulation Orders in respect of the following roads:

**DENMARK AND SILVER ROAD** - 1) **Denmark Road** from its junction with Sprowston Road for 10m westwards and 2) **Silver Road** from its junction with Sprowston Road for 10m south-eastwards to facilitate traffic signal upgrade works from 5th to 11th April 2025 (may continue until 23rd May 2025). Alternative route is via: 1) Denmark Road, Magdalen Road, Constitution Hill, Wall Road, Sprowston Road and vice versa; 2) Southeast bound - Sprowston Road, Magdalen Road, Bull Close Road, Charlton Road and Barrack Street. Northwest bound - Silver Road, Barrack Street, Barrack Street/Ketts Hill Roundabout, Barrack Street, Barrack Street/St Crispins Road Roundabout, Charlton Road Bull Close Road, Magdalen Road and Sprowston Road. The works promoter is Norfolk County Council.

**WARWICK STREET -** from its junction with Portersfield Road to its junction with Dover Street to facilitate lead replacement scheme works. The road will be temporarily closed, and vehicles shall be temporarily prohibited to park, stop, load from 31st March to 9th May 2025 (may continue until 9th November 2025). Alternative route is via: Dover Street, Unthank Road, Park Lane, Avenue Road, Portersfield Road and vice versa. The works promoter is Norfolk County Council.

**CAERNARVON ROAD -** from 85m north of its junction with Denbigh Road for 20m northwards to facilitate new water connection works from 1st to 3rd April 2025 (may continue until 15th May 2025). Alternative route is via: Denbigh Road, Wellington Road, Earlham Road, Caernarvon Road and vice versa. The works promoter is Anglian Water.

(ii) THEY HAVE MADE Temporary Traffic Regulation Orders in respect of the following roads:

**BOATMAN WAY FOOTPATH** - from its junction with Dereham Road for 62m south-westwards to facilitate Cadent Gas main replacement works from 24th March to 4th April 2025 (may continue until the 16th May 2025). Alternative route is via: Dereham Road, Larkman Lane, Beecheno Road.

**COZEN ROAD -** from 35m east of its junction with Hardy Road for 20m eastwards to facilitate Norfolk County Council gas pipe repair works from 24th to 26th March 2025 (may continue until 7th May 2025). Alternative route is via: N/A.

**HALF MILE ROAD** - from its junction with Aylsham Road for 50m westwards to facilitate Norfolk County Council manhole replacement works between 07:30 and 17:00 on 23<sup>rd</sup> March 2025 (may continue until 6<sup>th</sup> May 2025). Alternative route is via: Aylsham Road, Mile Cross Road, Half Mile Road and vice versa.

**MILL HILL ROAD** – from 100m south of its junction with Earlham Road for 50m southwards to facilitate Norfolk County Council water disconnections works from 24<sup>th</sup> to 28<sup>th</sup> March 2025 (may continue until 9<sup>th</sup> May 2025). Alternative route is via: Mill Hill Road, Earlham Road, Park Lane.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s)/ footpath(s). In the event of the start date being delayed the new start date will be displayed on site in advance. Where an Order is for a reason other than works it is because of the likelihood of danger to the public or of serious damage to the road/footpath. **Anticipated dates are stated but the Orders may continue until the end date where necessary or required.** The Orders are revoked on the end date or on the actual date of removal of the prohibition/restriction where earlier without further

notice. If necessary, the restrictions can have a maximum duration of 18 months for vehicular highway or 6 months for non-vehicular highway.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
