

Norfolk County Council (Norwich, Old Palace Road and Heigham Road)
Emergency Notice
Temporary Traffic Regulation Order 2025
Section 14(2) of the Road Traffic Regulation Act 1984

Norwich, Old Palace Road and Heigham Road (CTRO1231) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to emergency gas works the use by vehicles (of any class) of the Old Palace Road from its junction with Dereham Road for 10m northwards (the "Road A") and Heigham Road from its junction with Dereham Road for 10m southwards (the "Road B") in the City of Norwich will be temporarily prohibited/restricted.

Alternative route is via: Road A: Alternative northbound route - Dereham Road, Barn Road, Heigham Street and Old Palace Road. Alternative southbound route - Old Palace Road, Heigham Street, Barn Road, Barn Road/St Crispins Road Roundabout, Barn Road and Dereham Road. Road B: Dereham Road, Grapes Hill, Convent Road, Unthank Road, Earlham Road, Heigham Road and vice versa.

The closure/restriction is necessary because of the likelihood of danger to the public or serious damage to the Road A and Road B or both.

The closure/restriction is anticipated to take place from 10th to 17th April 2025 but the Road A and Road B may continue to be closed/restricted until the 30th April 2025 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall automatically revoke on the completion of the works / when the closure/restriction is no longer necessary or otherwise on the 30th April 2025 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

The works promoter for this restriction/closure is: Cadent

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

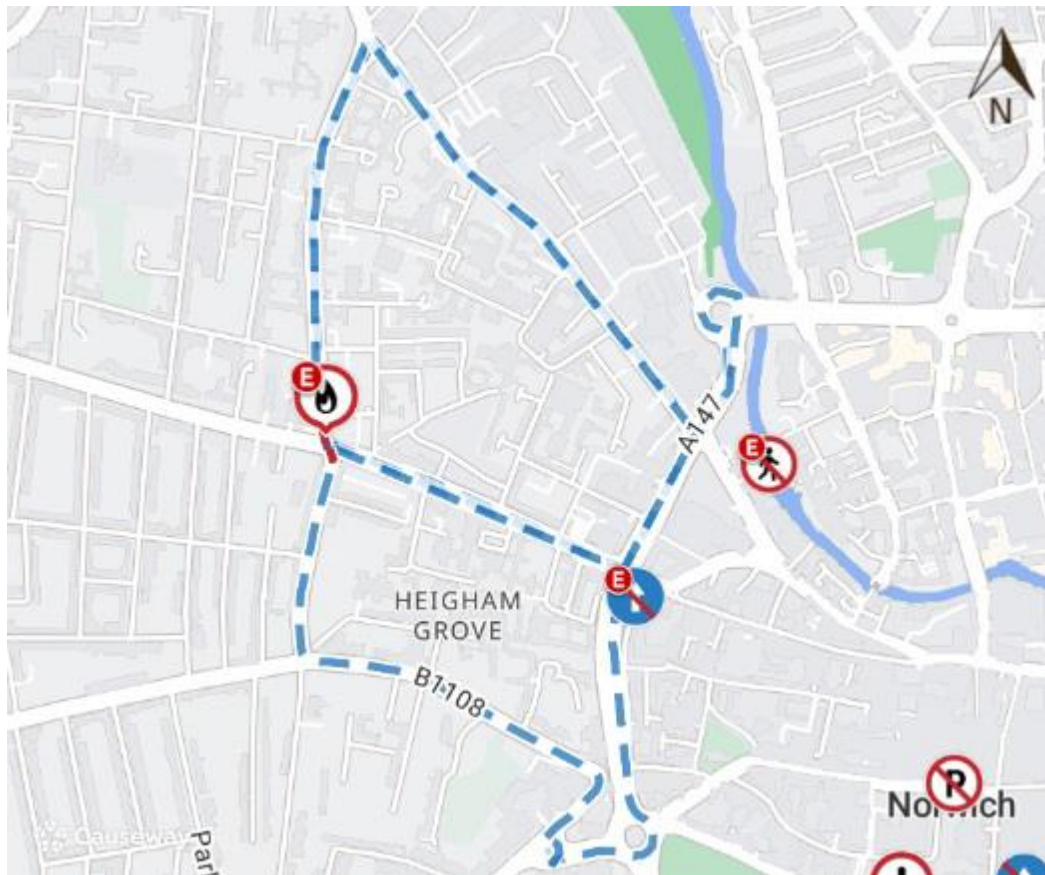
