**TEMPORARY TRAFFIC REGULATION ORDERS 2025 (NORWICH)**  
**Road Traffic Regulation Act, 1984**

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) **THEY PROPOSE TO MAKE** Temporary Traffic Regulation Orders in respect of the following roads:

**ANGEL ROAD** –from its junction with Patteson Road to its junction with Elm Grove Lane to facilitate surface dressing works between 19:00 and 23:59 on 28th July 2025 **phase 1** and between 19:00 and 23:59 on 6th August 2025 **phase 2** (may continue until 19th September 2025). Alternative route is via: Waterloo Road, Magdalen Road, Constitution Hill, Wall Road, Woodcock Road, Catton Grove Road. The works promoter is Norfolk County Council. **NB: Please note that the restrictions may be in place on 29th and 30th July 2025 for phase 1 and 7th and 8th August 2025 for phase 2 if works are unable to start on their anticipated dates.**

**CARROW ROAD BRIDGE** – from 25m northeast of its junction with King Street for 70m north-eastwards to facilitate bridge repair works between 19:00 and 05:00 from 31<sup>st</sup> July to 8<sup>th</sup> August 2025 only while signs indicating the closure are in place (may continue until 19<sup>th</sup> September 2025). Alternative route is via: King Street, Bracondale, Queens Road, Chapel Field Road, Grapes Hill, Barn Road, St Crispins Road, Barrack Street, Ketts Hill, Bishop Bridge Road, Riverside Road, Riverside, Koblenz Avenue, Carrow Road and vice versa. The works promoter is Norfolk County Council. **NB: The closure is expected to take place for one day within the anticipated dates period.**

**HALL ROAD** – from its junction with Cecil Road to its junction with Queens Road to facilitate surface dressing works between 19:00 and 12:00 from 26<sup>th</sup> July to 8<sup>th</sup> August 2025 (may continue until 19<sup>th</sup> September 2025). Alternative route is via: C820 Hall Road, A146 Barrett Road, A1054 Martineau Lane/ Bracondale, A147 Queens Road and vice versa. The works promoter is Norfolk County Council. **NB: These works are to be carried out in phases. Phase 1 is between 19:00 and 23:59 on 26<sup>th</sup> July. Phase 2 is between 05:00 and 12:00 on 7<sup>th</sup> August.**

**IPSWICH ROAD, LIME TREE ROAD, CECIL ROAD – 1) Ipswich Road (northbound only)** from its junction with Daniels Road to its junction with Town Close Road and; **2) Lime Tree Road** from its junction with Ipswich Road for 30m westwards and; **3) Cecil Road** from its junction with Ipswich Road for 30m eastwards to facilitate gas main replacement works from 27<sup>th</sup> July to 1<sup>st</sup> September 2025 (may continue until 1<sup>st</sup> March 2026). Alternative route is via: **1)** Daniels Road, A11 Newmarket Road; **2)** Westbound: Ipswich Road, Daniels Road, A11 Newmarket Road; Eastbound: Cecil Road, A11 Newmarket Road, St Stephens Road, St Stephens Road/ Chapelfield Road Roundabout, St Stephens Road, Ipswich Road; **3)** Ipswich Road, Lakenham Road, Hall Road. The works promoter is Cadent.

**JEX ROAD** - from its junction with Marl Pit Lane for 30m south eastwards to facilitate gas main upgrade works from 28th July to 8th August 2025 (may continue until 19th September 2025). Alternative route is via: Jex Avenue, Jex Road, Marl Pit Lane. The works promoter is Cadent.

**MILL HILL ROAD** – from its junction with Earlham Road to its junction with Park Lane to facilitate footway reconstruction works. The road will be temporarily closed and traffic shall be temporarily

prohibited to park, stop, load, and/or unload from 28<sup>th</sup> July to 19<sup>th</sup> September 2025 only while signs indicating restrictions are in place (may continue until 19<sup>th</sup> March 2026). Alternative route is via: Earlham Road, Park Lane and vice versa. The works promoter is Norfolk County Council. **NB: the closure and temporary parking restriction will only be put in place in phases on site.**

**MOUNT PLEASANT** – from 70m north of its junction with Newmarket Road for 40m north westwards to facilitate dropped kerb works from 28<sup>th</sup> to 30<sup>th</sup> July 2025 (may continue until 10<sup>th</sup> September 2025). Alternative route is via: Mount Pleasant, Newmarket Road, Christchurch Road, Unthank Road. The works promoter is Norfolk County Council.

**MOUSEHOLD LANE** – from its junction with Plaford Road to its junction with Corbett Avenue to facilitate utility connections works between 08:00 and 18:00 from 28<sup>th</sup> July to 10<sup>th</sup> August 2025 (may continue until 21<sup>st</sup> September 2025). Alternative route is via: A1042 Mousehold Lane/ Heartsease Lane, B1140 Plumstead Road/ Ketts Hill, A147 Barrack Street, A1151 Charlton Road/ Bull Close Road/ Magdalen Road/ Sprowston Road. The works promoter is ADL Traffic and Highways.

**PITT STREET** – Pitt Street Cycle Lane from its junction with St Crispins Road for 40m northwards to facilitate new gas connection works from 28<sup>th</sup> July to 1<sup>st</sup> August 2025 (may continue until 8<sup>th</sup> September 2025). Alternative route is via: N/A – Cyclists will be asked to dismount. The works promoter is Cadent.

(ii) **THEY HAVE MADE** Temporary Traffic Regulation Orders in respect of the following roads:

**ANGEL ROAD** - from its junction with Patteson Road to its junction with Elm Grove Lane to facilitate surface dressing works from 19<sup>th</sup> to 30<sup>th</sup> July 2025 (may continue until 10<sup>th</sup> September 2025). Alternative route is via: Waterloo Road, Magdalen Road, Constitution Hill, Wall Road, Woodcock Road, Catton Grove Road and vice versa. The works promoter is Norfolk County Council. **NB: These works will be carried out in 2 phases. Phase 1 will be between 19:00 and 23:59 on 19th July. Phase 2 will be between 19:00 and 23:59 on 30th July.**

**ESSEX STREET – 1) Essex Street** from 180m east of its junction with Unthank Road to 7m west of its junction with Suffolk Square and **2) Essex Street (westbound lane only)** from 220m east of its junction with Unthank Road to 10m west of its junction with Rupert Street and **3) Essex Street** from 1m west of its junction with Suffolk Square for 4m westwards to facilitate Anglian Water communication pipe replacement works. The Roads 1) and 2) shall be temporarily prohibited to park, stop, load, and/or unload and traffic over the Road 3) shall be prohibited to turn left onto Suffolk Square from 21<sup>st</sup> July to 8<sup>th</sup> August 2025 (may continue until 19<sup>th</sup> September 2025). Alternative route is via: Essex Street, Rupert Street, Vauxhall Street, Walpole Street, Union Street, Norfolk Street, Suffolk Square. The works promoter is Anglian Water.

**ST AUGUSTINES STREET** – from its junction with Sussex Street to its junction with Rose Yard to facilitate collapsing sewer repair works from 21<sup>st</sup> to 25<sup>th</sup> July 2025 (may continue until 5<sup>th</sup> September 2025). Alternative route is via: Drayton Road, Mile Cross Road, Heigham Street, Old Palace Road, Dereham Road, Barn Road, St Crispins Road, Oak Street, Sussex Street. The works promoter is Anglian Water.

**ST CRISPINS ROAD** - from its junction with St Crispins Road/Pitt Street Roundabout to its junction with St Crispins Road/Barrack Street Roundabout to facilitate surface dressing works between 19:00 and 05:00 from 22<sup>nd</sup> to 25<sup>th</sup> July 2025 (may continue until 5<sup>th</sup> September 2025). Alternative route is via: A147 Barrack Street/ Bishop Bridge Road/ Riverside Road/ Riverside/ Koblenz Avenue/ Carrow Road/ King Street/ Bracondale/ Queens Road/ Chapel Field Road/ Grapes Hill/ Barn Road/ St Crispins Road and vice versa. The works promoter is Norfolk County Council.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s)/ footpath(s). In the event of the start date being delayed the new start date will be displayed on site in advance. Where an Order is for a reason other than works it is because of the likelihood of danger to the public or of serious damage to the road/footpath. **Anticipated dates are stated but the Orders may continue until the end date where necessary or required.** The Orders are revoked on the end date or on the actual date of removal of the prohibition/restriction where earlier without further notice. If necessary, the restrictions can have a maximum duration of 18 months or 6 months in respect of footpaths, cycle paths, bridleways, restricted byways, and byways open to all traffic (BOAT).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
