

Norfolk County Council proposes to make a Temporary Traffic Regulation Order (the "Order") (CTRO1286) affecting the Ipswich Road (northbound only) from its junction with Daniels Road to its junction with Town Close Road ("Road A") and; Lime Tree Road from its junction with Ipswich Road for 30m westwards ("Road B") and; Cecil Road from its junction with Ipswich Road for 30m eastwards ("Road C") in the City of Norwich to facilitate gas main replacement works, the Roads A–C will be temporarily closed/restricted (except for pedestrian access) for the duration of the works/period the closure is necessary which is anticipated to be from 27th July to 1st September 2025, but may continue to be closed/restricted until the 1st March 2026 where the closure/restriction is still required beyond the anticipated dates.

Alternative route is via: Road A: Daniels Road, A11 Newmarket Road; Road B: Westbound: Ipswich Road, Daniels Road, A11 Newmarket Road; Eastbound: Cecil Road, A11 Newmarket Road, St Stephens Road, St Stephens Road/Chapelfield Road Roundabout, St Stephens Road, Ipswich Road; Road C: Ipswich Road, Lakenham Road, Hall Road.

The works promoter for this restriction/closure is: Cadent.

Vehicular access will be permitted to a final destination in the Roads A–C where signs indicating such access is possible and permitted are in place.

The Order shall automatically revoke on the completion of the works/when the closure is no longer necessary or otherwise on the 1st March 2026 without further notice.

If necessary, the restriction could run for a maximum period of 18 months from the date the Order is effective.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

In the event of the start date being delayed the new start date will be displayed on site in advance.

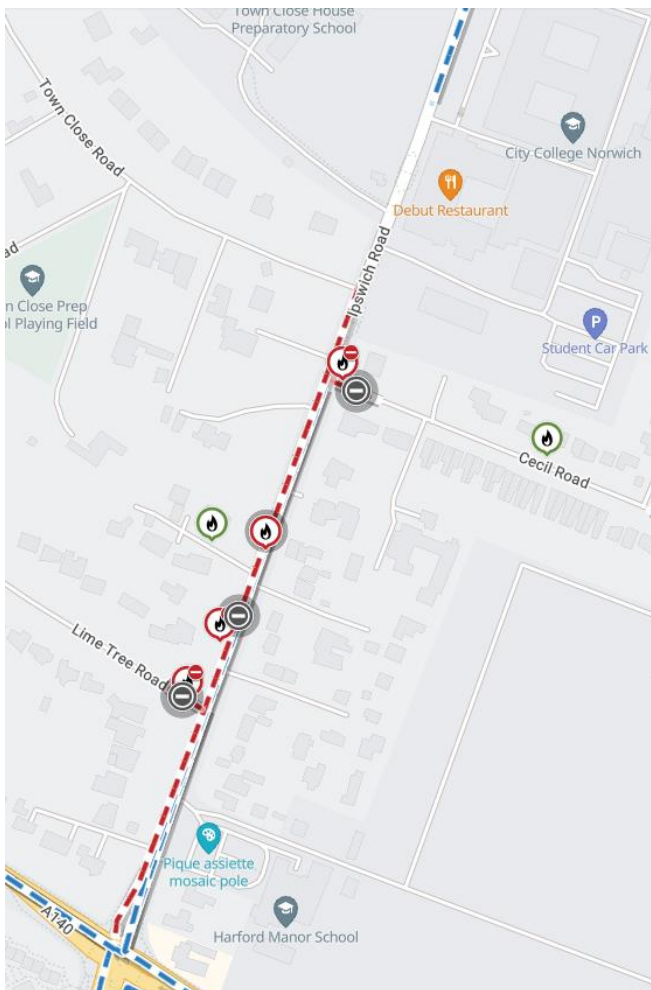
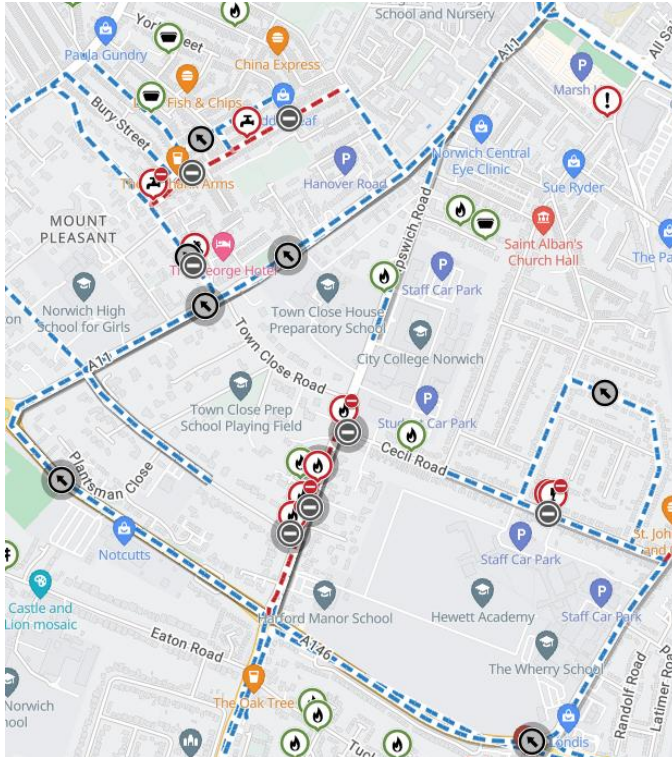
