

Norfolk County Council proposes to make a Temporary Traffic Regulation Order (the "Order") (CTRO1345) affecting the Grove Road from 105m southwest of its junction with Brazen Gate for 20m south westwards ("Road A") and Southwell Road from its junction with Grove Road for 20m south eastwards ("Road B") and Grove Road from 1m west of its junction with Brazen Gate for 25m south westwards ("Road C") in the City of Norwich to facilitate carriageway defect rectification works, the Roads A and B will be temporarily closed/restricted (except for pedestrian access) and the Road C shall be temporarily subject to the suspension of the existing bus gate restriction for the duration of the works/period the closure is necessary which is anticipated to be from 16th to 17th October 2025, but may continue to be closed/restricted until the 28th November 2025 where the closure/restriction is still required beyond the anticipated dates.

Alternative route is via: Grove Road Northbound diversion - Grove Walk, Cecil Road, Hall Road, A147, Brazen Gate. Grove Road Southbound diversion - A147, St Stephen Street, Ipswich Road, Cecil Road, Grove Walk. Southwell Road Diversion - Hall Road, Cecil Road, Grove Walk, Grove Road.

The works promoter for this restriction/closure is: Cadent.

While the Order is in effect (in force), The Norwich City Council (Brazen Gate Bus Lane) (Traffic Regulation) Order 2018 shall be suspended.

Vehicular access will be permitted to a final destination in the Roads A-C where signs indicating such access is possible and permitted are in place.

The Order shall automatically revoke on the completion of the works/when the closure and suspension is no longer necessary or otherwise on the 28th November 2025 without further notice.

If necessary, the restriction and suspension could run for a maximum period of 18 months from the date the Order is effective.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/closure imposed by the Order shall be guilty of an offence.

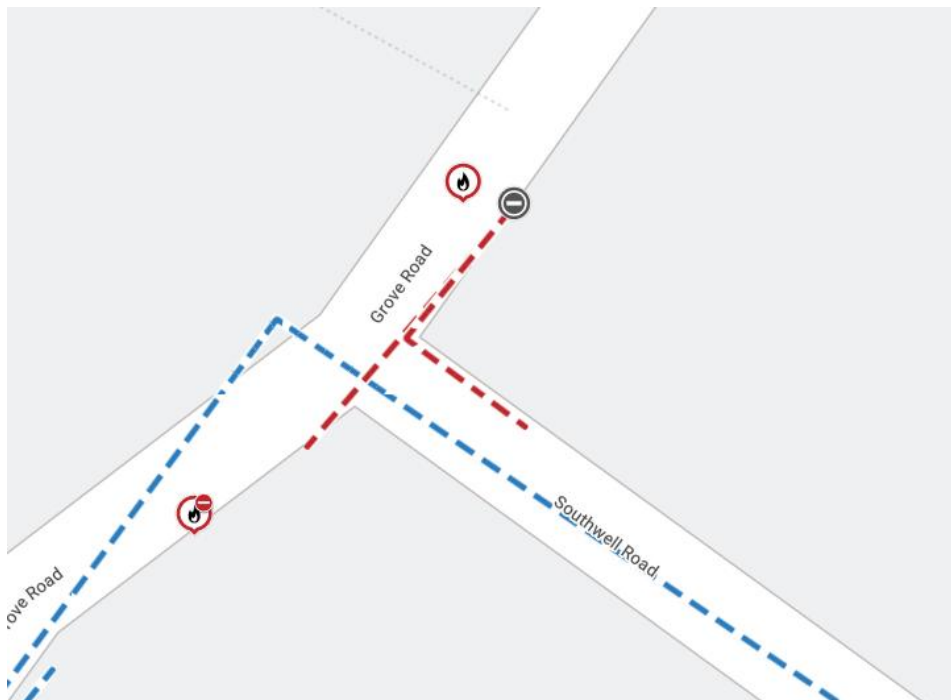
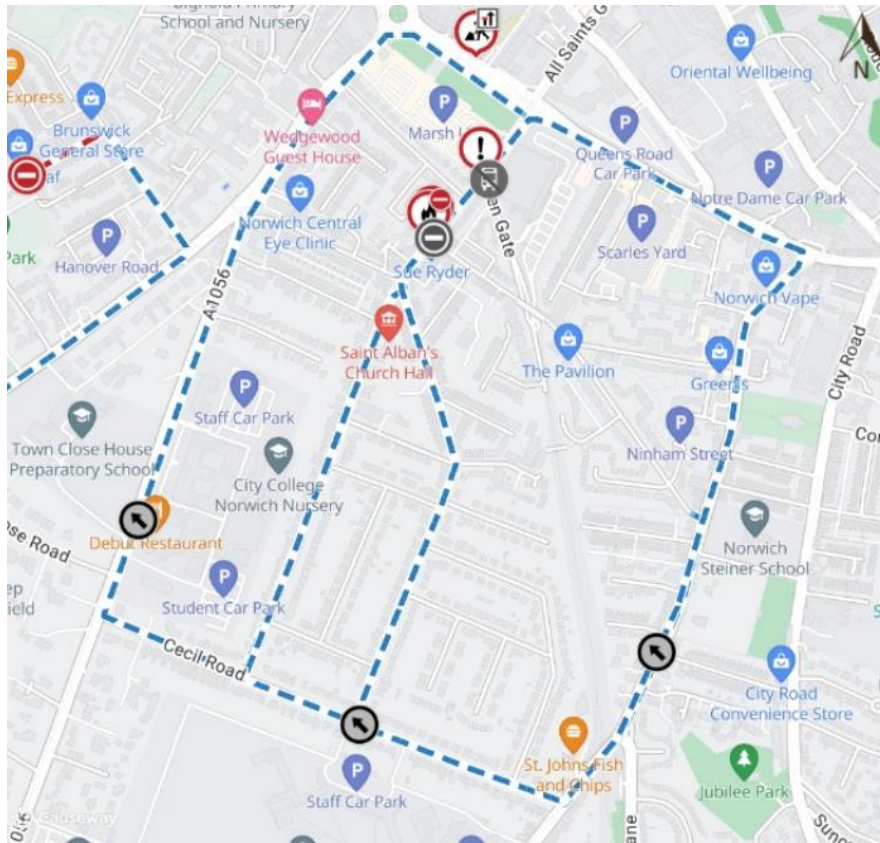
Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

In the event of the start date being delayed the new start date will be displayed on site in advance.

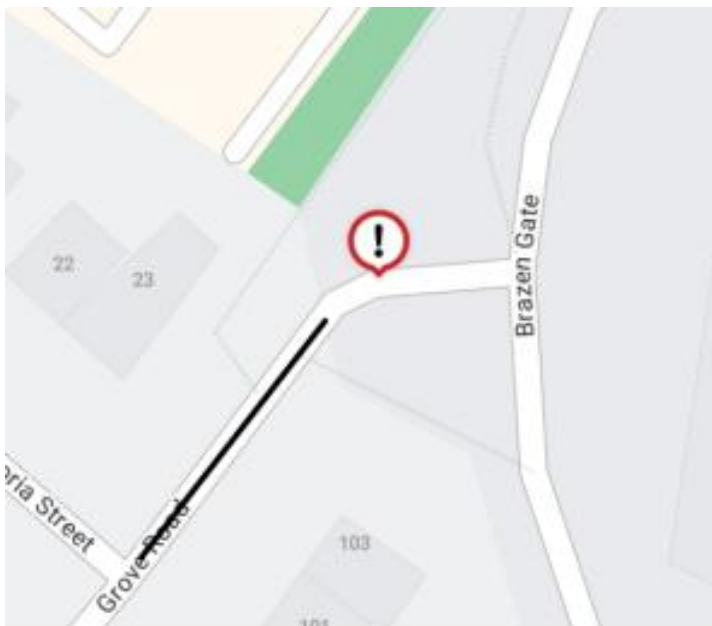
