NORWICH CITY COUNCIL (SOUTHERN AREA) (PROHIBITION AND RESTRICTION OF WAITING) (ASTELL ROAD, COLEBURN ROAD, SANDY LANE AND THEOBALD ROAD) AMENDMENT TRAFFIC REGULATION ORDER 2018

The City Council of Norwich pursuant to an agency agreement with the Norfolk County Council under Section 101 of the Local Government Act 1972 and in exercise of the powers of the Norfolk County Council under Sections 1, 2, 4 and 122 of the Road Traffic Regulation Act 1984 and all other enabling provisions hereby makes the following Order: -

1. Citation and Commencement

- 2. The City of Norwich (Southern Area) (Prohibition and Restriction of Waiting) (Consolidation) Order 1982 (as amended) (hereinafter called the "1982 Order") is amended as specified in Article 3 of this Order.
- 3. In Schedule 1 of the 1982 Order references to Astell Road, Coleburn Road, Sandy Lane and Theobald Road are amended as specified in the Schedule of this Order.
- 4. Insofar as any provision of this Order conflicts with any previous Order relating to the lengths of road specified in Article 3 and the Schedule to this Order, that provision of this Order shall prevail.

Schedule 1 of the 1982 Order

No Waiting At Any Time

Astell Road – New provision

Insert the following references:-

Both sides

From its junction with Coleburn Road to a point 5 metres south-east of the south-eastern back of the highway line of Coleburn Road.

From its junction with Theobald Road to a point 5 metres north-west of the north-western back of the highway line of Theobald Road.

Coleburn Road – New provision

Insert the following reference:-

North-west side

From its junction with Theobald Road to a point 10 metres north-west of the north-western back of the highway line of Theobald Road.

From a point 1 metre south-west of the boundary line between Nos.104/106 Coleburn Road to a point in line with the boundary line of Nos.108/110 Coleburn Road.

From a point 8 metres north-east of the boundary line between Nos.52/54 Coleburn Road to a point 11 metres south-west of that boundary line.

From its junction with Sandy Lane to a point 20 metres south-west of the south-western back of the highway line of Sandy Lane.

South-east side

From its junction with Theobald Road to a point 10 metres north-west of the north-western back of the highway line of Theobald Road.

From a point 7 metres north-east of the north-eastern back of the highway line of Astell Road to a point 7 metres south-west of the south-western back of the highway line of Astell Road.

From its junction with Sandy Lane to a point 20 metres south-west of the south-western back of the highway line of Sandy Lane.

Sandy Lane – Additional provision

Insert the following references:-

North-east side

From a point 14 metres west of the boundary line of Nos.9/11 Sandy Lane to a point in line with the boundary line of Nos.19/23 Sandy Lane.

From a point 12 metres north of the northern back of the highway line of Theobald Road to a point in line with the boundary line of Nos 47/49 Sandy Lane.

South-west side

From a point in line and opposite with the boundary line of Nos.9/11 Sandy Lane to a point 15 metres south east of the boundary line of Nos 28/30 Sandy Lane.

From a point 12 metres north of the northern back of the highway line of Theobald Road to a point in line with and opposite to the boundary line between Nos 47/49 Sandy Lane.

Insert the following references:-

Both Sides

From its junction with Sandy Lane to a point in line with the north-eastern boundary line of No.1 Theobald Road.

From a point in line with the boundary line between Nos.27/29 Theobald Road to a point in line with the boundary line between Nos.33/35 Theobald Road.

From a point 3 metres south of the boundary line between Nos.45/47 Theobald Road to a point in line with the boundary line between Nos.51/53 Theobald Road.

From a point 7 metres south-west of the boundary line between Nos.93/95 Theobald Road to a point 7 metres north-east of the boundary line between Nos.101/103 Theobald Road.
