MODIFICATION ORDER 2016

This Order is made by Norfolk County Council ("the Authority") under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Definitive Map and Statement of Public Rights of Way for the County of Norfolk ("the Definitive Map and Statement") require modification in consequence of events specified in Section 53(3)(b) of the Act, namely:-

(a) Section 53(3)(b) – the expiration, in relation to any way in the area to which the map relates, of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public path

The Authority have consulted with every local authority whose area includes the land to which the Order relates.

The Norfolk County Council hereby order that:-

- 1. For the purposes of this Order the relevant date is 1st November 2016
- 2. The Definitive Map and Statement of Public Rights of Way for the County of Norfolk shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as the Norfolk County Council (Norwich) Modification Order 2016.

PART I

Modification of the Definitive Map

Description of path or way to be added

<u>Footpath</u> (Sprowston Road to Anthony Drive) Starts at the A1151 Sprowston Road at map reference TG 2386 1090 (point A on annexed map) and runs in a generally south easterly direction between boundary features at a width of 3.7 metres for a distance of approximately 46 metres to map reference TG 2389 1088 (point B on annexed map) where the width of the path reduces to 1 metre and continues in a generally south easterly direction for approximately 16 metres, gradually increasing in width along this length to 1.7 metres, where it meets the U42003 Anthony Drive at map reference TG 2390 1086 (point C on annexed map).

PART II

Modification of Definitive Statement

<u>Footpath</u> (Sprowston Road to Anthony Drive) Starts at the A1151 Sprowston Road at map reference TG 2386 1090 and runs in a generally south easterly direction between boundary features at a width of 3.7 metres for a distance of approximately 46 metres to map reference TG 2389 1088 where the width of the path reduces to 1 metre and continues in a generally south easterly direction for approximately 16 metres, gradually increasing in width along this length to 1.7 metres, where it meets the U42003 Anthony Drive at map reference TG 2390 1086.


