Exhumation is only permitted with the appropriate authority, which may be a Ministry of Justice licence and/or a faculty from the Church of England. All of the required permissions must be obtained by the person applying for the exhumation

Exhumation Of Cremated Remains - The exhumation fee is also subject to VAT if the exhumed cremated remains are not subsequently re-buried. The exhumation of cremated remains is only possible if the ashes are known to have been interred within a container. In the event that the ashes cannot be successfully identified this service is non-refundable

VALUE ADDED TAX

The schedules & fees indicates the V.A.T. status of individual charges. The following sets out an explanation of the V.A.T liability in respect of the various categories.

There are 4 categories for V.A.T. purposes with the supply of goods and/or services are grouped. As a general rule V.A.T. should be applied at the standard rate (S) - currently 20% unless the supply falls within one of the other 3 categories, for which no V.A.T. is applied. These categories are shown below:-

- (i) Zero Rated (ZR) No V.A.T. to be applied to the supply of goods or derives but a registered trader can reclaim tax on supplies which he/she incurs for the purpose of making zero rated supplies.
- (ii) Exempt (E) No V.A.T. to be applied on the supply of goods or services and as a registered trader cannot recover any tax paid on supplies provided.
- (iii)Non-Business (NB) There are special rules relating to local authorities in this category in that their statutory and other non-business activities will be outside the scope of the tax and any V.A.T. falling on purchases by them for goods or service for these activities would be deductible under the normal mechanism. In order to avoid the tax on these purchases falling on the Council taxpayer special arrangements are made.

In summary, any goods or services not falling within (i) to (iii) above must be treated as standard rated.
