TEMPORARY TRAFFIC REGULATION ORDERS 2023 (NORWICH CITY)
Road Traffic Regulation Act, 1984

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:-

(i) THEY PROPOSE TO MAKE Temporary Traffic Regulation Orders in respect of the following roads:-

GROSVENOR ROAD - from 10m west of its junction with Unthank Road for 50m westwards to facilitate works on an overhead structure between 09:30 and 15:30 on 28th March 2023. Alternative route is via: Grosvenor Road, Bathurst Road, Clarendon Road, Unthank Road and vice versa.

ROSEBAY CLOSE - the footpath from outside no 17 to its joining with Bryony Close to facilitate telecoms installation works from 29th to 31st March 2023. Alternative route is via: Bryony Close, Ives Road, Ives Road Footpath North Of 31 To Rosebay Close, Rosebay Close Footpath in front of 17 to Bryony Close and vice versa.

PLUMSTEAD ROAD - from its junction with Heartsease Lane/Plumstead Road Roundabout for 20m north-eastwards to facilitate trial holes for transforming cities scheme between 09:00 and 16:00 from 28th to 29th March 2023. Alternative route is via: Plumstead Road East, Woodside Road, Salhouse Road, Heartsease Lane and vice versa (Thorpe St. Andrew, Sprowston).

(ii) THEY HAVE MADE Temporary Traffic Regulation Orders in respect of the following roads:-

IVES ROAD - footpath Norwich 4F39 from its junction with Ives Road for 44m north-eastwards to facilitate fibre network installation works from 14th to 24th March 2023. Alternative route is via: Ives Road, Bryony Close, Rosebay Close footpath to Bryony Close and vice versa.

LITTLE BETHEL STREET - cycle path from its junction with Bethel Street to its junction with Chapel Field North to facilitate material storage and welfare for building refurbishment works from 13th March to 12th September 2023. Alternative route is N/A. Cyclists will be asked to dismount and use the footpath.

MOUNTERGATE - footpath from its junction with Netherconesford for 20m westwards to facilitate cable installation works between 07:00 and 17:00 on 16th March 2023. Alternative route is via: Mountergate, King Street, Rose Lane and vice versa.

The effect of the Orders will be to prohibit any vehicle (except where exceptions are mentioned) to enter, travel or park in those roads. Alternative routes are shown where applicable and pedestrian access will be maintained at all times. If necessary, the restrictions could run for a maximum period of 18 months from the date of the Orders (6 months in respect of footpaths).
