- 2. Since that time, some limited amendments to the landscape proposals have been undertaken, with Revision D updating Revision C.
- 3. In order to increase the width of pedestrian paths along St Georges Street alongside the cycle path the soft landscaped areas have been reconfigured, but the total amount of soft landscaped area (and planting types / species within them) and number of trees remain the same overall as summarised in the table below and shown in comparison plans appended to this note.


4. While these amendments would affect the Biodiversity Net Gain calculation, the overall effect is considered to be negligible given the limited extent of the changes. Moreover, the extent of net gain as set out in the January assessment is such that limited amendments to the landscaping will make no significant difference to the high level of gain to be delivered. On this basis the formal assessment has not been updated.

In order to increase the width of pedestrian paths along St Georges Street alongside the cycle path the soft landscaped areas have been reconfigured, but the total amount of soft landscaped area (and planting types/species within them) and number of trees remain the same overall as summarised in the table and shown in the following comparison plans.
