# Norfolk County Council (South-Eastern Controlled Parking Zone) (Norwich, Cecil Road) Amendment Traffic Regulation Order 2023

The Norfolk County Council in exercise of powers under sections 1, 2, 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

### 1 <u>Citation and Commencement</u>

This Order may be cited as the Norfolk County Council (South-Eastern Controlled Parking Zone) (Norwich, Cecil Road) Amendment Traffic Regulation Order 2023 and shall come into effect for all purposes on the 17<sup>th</sup> day of April 2023.

- 2. The Norwich City Council (Controlled Parking Zone) (South-East Area) Traffic Regulation Order 1993 (as amended) (hereinafter referred to as the "1993 Order") is amended as specified in Articles 3, 4 and 5 of this Order.
- 3. Schedule 2 of the 1993 Order is amended by the deletion and addition of the references to Cecil Road as specified in Schedule 1 of this Order.
- 4. Schedule 8 of the 1993 Order is amended by the deletion and addition of the reference to Cecil Road as specified in Schedule 2 of this Order.
- 5. Schedule 108 of the 1993 Order is amended by the deletion and addition of the reference to Cecil Road as specified in Schedule 3 of this Order.
- 6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in this Order, that provision of this Order shall prevail.
