**Temporary Restriction of Traffic Movement**

Norfolk County Council, HEREBY GIVE NOTICE that to facilitate the **Kings Coronation Street Party**, have made a Traffic Order, the effect of which will be to temporarily restrict vehicular traffic on **Theobald Road** in the TOWN OF **Norwich**

The Order will come into effect on **06<sup>th</sup> May 2022** between the hours of **12:00** to **16:00**. The road will be temporarily restricted (except for emergency and pedestrian access).

Restriction on traffic will only be enforced until normal traffic flow can be maintained.

Where appropriate during the period of the closure temporary suspension of existing permanent Traffic Orders may be imposed.


