Norfolk County Council TEMPORARY TRAFFIC REGULATION ORDERS 2023 (NORWICH CITY) Road Traffic Regulation Act, 1984

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) **THEY PROPOSE TO MAKE** Temporary Traffic Regulation Orders in respect of the following roads:

CECIL ROAD - from its junction with Ipswich Road for 30m westwards to facilitate UK Power Networks link-box replacement works between 08:00 on 29th May and 17:00 on 1st June 2023. Alternative route is via: Ipswich Road, Lakenham Road, Hall Road, Cecil Road.

DEREHAM ROAD - from its junction with Grapes Hill to its junction with Douro Place (westbound only) to facilitate sewer development works from 22nd May to 2nd June 2023. Alternative route is via: Barn Road, Grapes Hill, Convent Road, Unthank Road, Earlham Road, Farrow Road, Guardian Road. HGV Alternative route - Grapes Hill, Chapelfield Road, St Stephens Road, Newmarket Road, Mile End Road, Colman Road, Farrow Road, Guardian Road Dereham Road.

DUKE STREET - from its junction with Charring Cross to its junction with St Crispins Road to facilitate crane dismantling works from 27th to 28th May 2023; or 3rd to 4th June 2023, only while signs indicating the closure are in place. NB. The closure will only be in close for one of the specified periods. Alternative route is via: St Andrews Street, Bank Plain, Upper King Street, Tombland, Palace Street, Whitefriars, Barrack Street, St Crispins Road Roundabout, St Crispins Road.

QUEBEC ROAD - from its junction with Kett's Hill for 20m southwards to facilitate water cover maintenance works from 30th May to 2nd June 2023. Alternative route is via: Kett's Hill, Britannia Road, Wolfe Road, Quebec Road and vice versa.

SCARNELL ROAD - from its junction with Cunningham Road for 50m southwards to facilitate new electrical connection works from 30th May to 7th June 2023. Alternative route is via: Cunningham Road, Friends Road and vice versa.

VALENTINE STREET AND GOLDING PLACE - 1) **Golding Place footpath** for its entire length; and 2) parking bay on **Valentine Street** to facilitate structure safety restoration works. The Order continues the provisions of the Notice dated 3rd May 2023 that 1) the footpath will be temporarily closed (except for access); and 2) traffic using the road will be temporarily prohibited from parking, stopping and loading/unloading vehicles. The restriction will continue in effect from 24th May to 2nd November 2023 (previously 3rd to 23rd May 2023). Alternative route is N/A.

(ii) **THEY HAVE MADE** Temporary Traffic Regulation Orders in respect of the following road:

COWGATE - from its junction with Bull Close for 30m eastwards to facilitate Anglian water maintenance works from 17th to 19th May 2023. Alternative route is via: Eastbound - Bull Close, Bull Close Road, Charlton Road, Barrack Street/St Crispins Roundabout and Cowgate. Westbound - Cowgate, Charlton Road, Bull Close Road and Bull Close.

DOGWOOD ROAD - footpath Norwich 4F23 from its junction with Dogwood Road for its entire length to facilitate telecoms installation works from 15th to 19th May 2023. Alternative route is via: Dogwood Road, Fiddlewood Road, Fiddlewood Road Footpath and vice versa.

MOUSEHOLD LANE - from its junction with Alford Grove to its junction Moorland Close to facilitate private development highway amendment works. The road will be temporarily subject to a 20mph speed restriction; and traffic using the road will be temporarily prohibited from parking, stopping and loading/unloading vehicles from 18th May to 31st July 2023. Alternative route is N/A.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s). All other restrictions are included where necessary. In the event of the start date being delayed the new start date will be displayed on site in advance. Alternative routes are shown where applicable and pedestrian access will be maintained at all times. If necessary, the restrictions could run for a maximum period of 18 months from the date of the Orders or 6 months in respect of footpaths, cycle paths, bridleways, restricted byways, and byways open to all traffic (BOAT).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
