

**Norfolk County Council**  
**TEMPORARY TRAFFIC REGULATION ORDERS 2023 (NORWICH)**  
**Road Traffic Regulation Act, 1984**

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) **THEY PROPOSE TO MAKE** Temporary Traffic Regulation Orders in respect of the following roads:

**GEORGE BORROW ROAD, LOUND ROAD, HODGSON ROAD (PHASE 1) - 1) George Borrow Road** from its junction with Hodgson Road for 92m southwards; and **2) Lound Road** from its junction with George Borrow Road for 48m eastwards to facilitate gas main replacement scheme works from 7<sup>th</sup> to 18<sup>th</sup> August 2023. Alternative route is via: Coleman Road, Earlham Road, George Borrow Road and Vice Versa.

**RIVERSIDE ROAD BACK LANE** - from its junction with Chalk Hill Road for 30m southwards to facilitate water utility maintenance works from 7<sup>th</sup> to 11<sup>th</sup> August 2023. Alternative route is via: Chalk Hill Road, Riverside Road, Riverside Road Back Lane to Chalk Hill Road and vice versa.

**SALTER AVENUE** - footpath Norwich 4F535 from its junction with Salter Avenue to its junction with Jasmine Close to facilitate gas main works from 7<sup>th</sup> to 18<sup>th</sup> August 2023. **Please note that these dates replace any previously advertised dates in respect of this location.** Alternative route is via: Salter Avenue, Primula Drive, Jasmine Close and vice versa.

(ii) **THEY HAVE MADE** Temporary Traffic Regulation Orders in respect of the following roads:

**EARLHAM GREEN LANE** - from its junction with Hutchinson Road for 50m southwards to facilitate UK Power Networks electrical connection works from 1<sup>st</sup> to 11<sup>th</sup> August 2023. Alternative route is via: Hutchinson Road, Earlham West Centre, Rockingham Road, Wilberforce Road, Earlham Road, Earlham Green Lane and vice versa.

**THE AVENUES** - from its junction with Colman Road to its junction with Bunnett Square to facilitate essential gas works from 31<sup>st</sup> July to 11<sup>th</sup> August 2023. Alternative route is via: The Avenues, Bluebell Road, Earlham Road, Colman Road and vice versa.

**THORPE ROAD** - from its junction with Riverside Road to its junction with A1242 Clarence Road to facilitate Norfolk County Council carriageway maintenance works between 06:00 and 13:00 on 30<sup>th</sup> July 2023. Alternative route is via: East Bound – Riverside, Koblenz Avenue, Canary Way, Carrow Road, Clarence Road; Rosary Road - Rosary Road, Riverside Road then joins Eastbound diversion route; and Westbound - Thorpe Road, Carrow Road, Canary Way, Koblenz Avenue.

**UNTHANK ROAD** - from its junction with College Road for 30m north-eastwards to facilitate Anglian Water new connection works between 19:00 and 06:00 from 3<sup>rd</sup> to 4<sup>th</sup> August 2023. Alternative route is via: Unthank Road, Chapel Field Road, St Stephens Road, Ipswich Road, Newmarket Road, Mile End Road and vice versa.

**WELLESLEY AVENUE NORTH** - from its junction with Plumstead Road for 30m southwards to facilitate UK Power Networks link box replacement works from 31<sup>st</sup> July to 2<sup>nd</sup> August 2023. Alternative route is via: Plumstead Road, Ketts Hill, Wolfe Road, Wellesley Avenue North and vice versa.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s). All other restrictions are included where necessary. In the event of the start date being delayed the new start date will be displayed on site in advance. Alternative routes are shown where applicable and pedestrian access will be maintained at all times. If necessary, the restrictions could run for a maximum period of 18 months from the date of the Orders or 6 months in respect of

footpaths, cycle paths, bridleways, restricted byways, and byways open to all traffic (BOAT).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
