### Norfolk County Council (Norwich, Southern Area) proposed (20mph Speed Limit) Speed Restriction Amendment Order 2023

to amend the Norwich City Council Speed Restriction (Consolidation) Order 2005 (as amended) to introduce a 20mph speed limit, the effect of which is that no vehicle, other than an emergency vehicle, may proceed at a speed in excess of 20 miles per hour along the A1056/10 Ipswich Road from its junction with Grove Avenue U42823/10 southwards for a distance of 485m.
