## Norfolk County Council TEMPORARY TRAFFIC REGULATION ORDERS 2023 (NORWICH) Road Traffic Regulation Act, 1984

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) THEY PROPOSE TO MAKE Temporary Traffic Regulation Orders in respect of the following roads:

**BELL ROAD AND VIOLET ROAD - 1) Bell Road** from its junction with Silver Road for 30m westwards; and **2) Violet Road** from its junction with Silver Road for 50m eastwards to facilitate City Fibre installation works from 9<sup>th</sup> to 13<sup>th</sup> October 2023. Alternative route is via: 1) Bell Road, Branford Road, Sprowston Road, Silver Road and vice versa; and 2) Violet Road, Gertrude Road, Sprowston Road and vice versa.

**BOATMAN WAY** - from its junction with Clover Hill for 30m westwards to facilitate water utility works between 08:00 and 14:00 on 9<sup>th</sup> October 2023. Alternative route is via: Holworthy Road, Holworthy Road Footpath Opposite Webster Close to Houghton Close, Houghton Close, Clover Hill Road and vice versa.

**CLARKSON ROAD** – from its junction with Larkman Lane for 30m south-eastwards to facilitate manhole cover repair works between 19:00 and 06:00 from 9<sup>th</sup> to 10<sup>th</sup> October 2023. Alternative route is via: Larkman Lane, Dereham Road, Cadge Road, Clarkson Road and vice versa.

DRAYTON ROAD, DRAYTON HIGH ROAD AND SWEET BRIAR ROAD/BOUNDARY ROAD - 1) Drayton Road from its junction with Sweet Briar Road to its junction with Hellesdon Park Road; 2) Drayton High Road from its junction with Sweet Briar Road to its junction with Whiffler Road; and 3) Sweet Briar Road/Boundary Road from its junction with Black Berry Court to its junction with Whiffler Road to facilitate resurfacing works. The roads 1) and 2) will be temporarily closed (except for access) and 3) will be temporarily subject to a 20mph speed restriction on Monday to Friday between 20:00 and 06:00 from 9<sup>th</sup> to 20<sup>th</sup> October 2023, only while signs indicating the closure are in place. Alternative route is via: 1) Drayton High Road A1067, Fakenham Road A1067, Broadland Northway A1270, Holt Road A140, Cromer Road A140, Boundary Road and vice versa. 2) Boundary Road, Cromer Road, Aylsham Road, Mile Cross Road, Drayton Road and vice versa (Horsham St. Faith and Newton St. Faith, Hellesdon, Taverham, Attlebridge, Horsford, Drayton).

**GLEBE ROAD** - from its junction with Girton Road for 40m north-westwards to facilitate power cable installation works from 9<sup>th</sup> to 11<sup>th</sup> October 2023. Alternative route is via: Girton Road, College Road, Bensley Road, Glebe Road.

**RECORDER ROAD** - from its junction with Prince of Wales Road for 30m northwards to facilitate new electrical connection works from 9<sup>th</sup> to 24<sup>th</sup> October 2023. Alternative route is via: Prince of Wales Road, Rose Lane, Cattle Market Street Market Avenue, Agricultural Hall Plain, Prince of Wales Road, Recorder Road, St Faiths Lane, Cathedral Street.

(ii) THEY HAVE MADE Temporary Traffic Regulation Orders in respect of the following roads:

**HORN-PIE ROAD** – from its junction with Pishmire Close to its junction with Caddow Close to facilitate fibre installation works from 2<sup>nd</sup> to 6<sup>th</sup> October 2023. Alternative route is via: Horn-Pie Road, Bishy Barnebee Way.

**LOUND ROAD** - from its junction with Colman Road for 50m westwards to facilitate gas main replacement works from 4<sup>th</sup> to 11<sup>th</sup> October 2023. Alternative route is via: George Borrow Road, Earlham Road, Colman Road and vice versa.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
