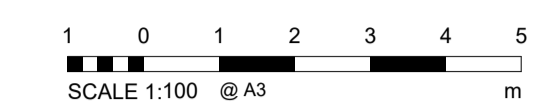
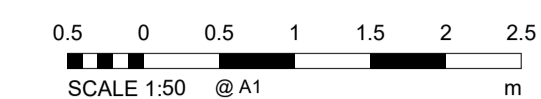
Completing the form

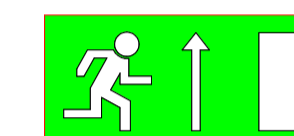

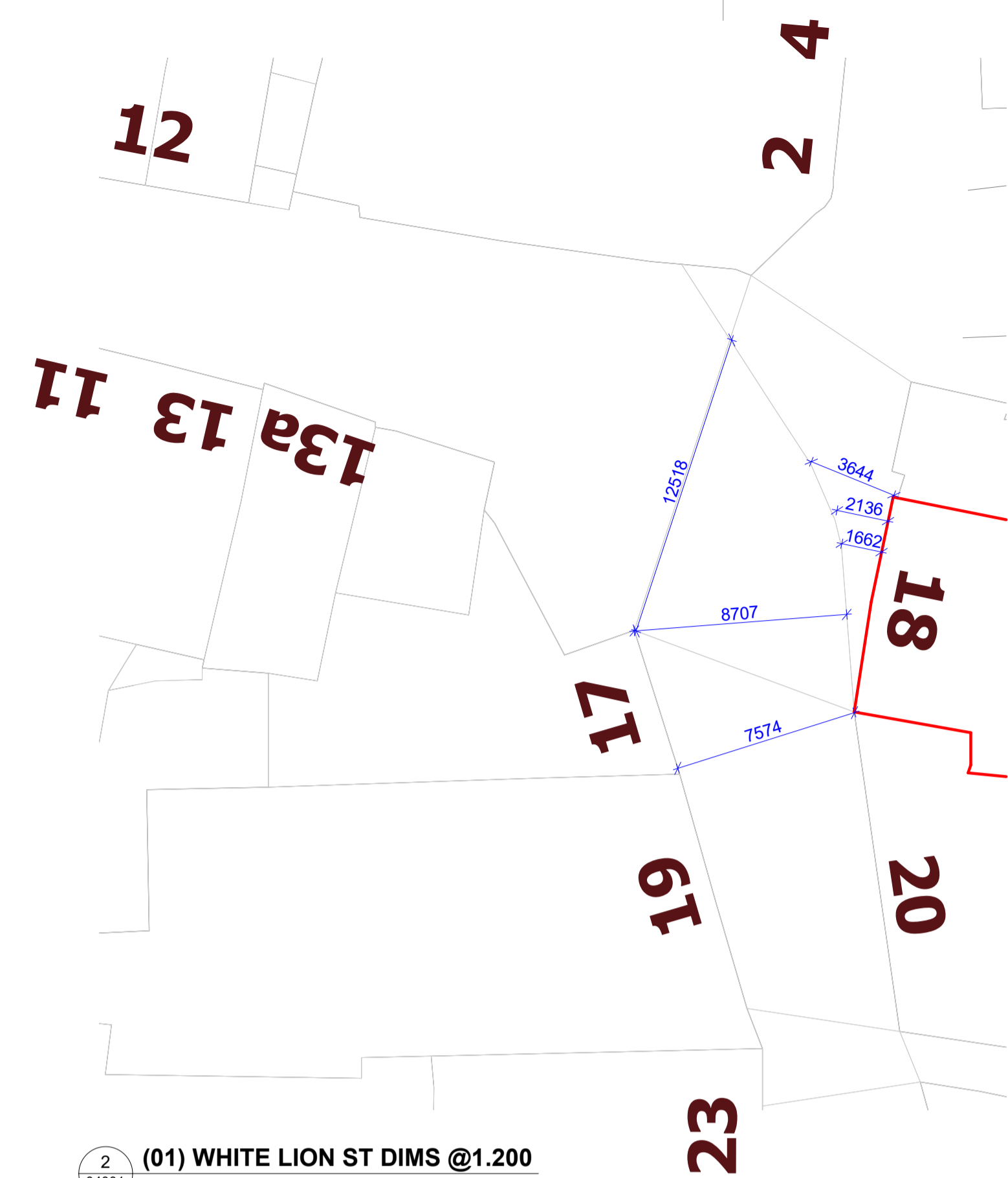

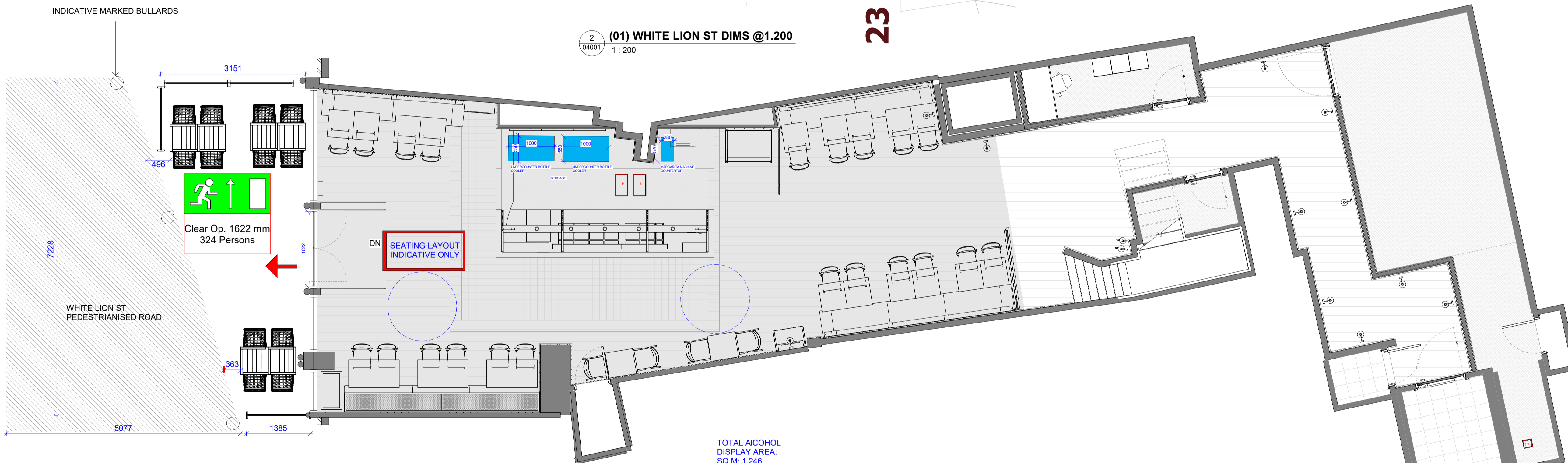
