## Norfolk County Council TEMPORARY TRAFFIC REGULATION ORDERS 2023 (NORWICH) Road Traffic Regulation Act, 1984

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) THEY PROPOSE TO MAKE Temporary Traffic Regulation Orders in respect of the following roads:

**BOATMAN WAY (FOOTPATH & CYCLE PATH)** – the segregated footpath and cycle path Boatman Way from its junction with Clover Hill Road for 55m westwards to facilitate Anglian Water meter exchange works between 08:00 and 14:00 on 12th December 2023. Alternative route is via: Holworthy Road Footpath Opposite Webster Close To Houghton Close, Holworthy Road, Clover Hill Road.

**HEATHSIDE ROAD-** from 10m south of its junction with Cotman Road for 50m to facilitate electrical connection works from 11th to 15th December 2023. Alternative route is via: Heathside Road, Thorpe Road, Telegraph Lane East, Cotman Road and vice versa (Thorpe St. Andrew).

**HIGHLAND ROAD** - from its junction with Christchurch Road for 40m southwards to facilitate link box replacement works from 11th to 13th December 2023. Alternative route is via: Highland Road, Colman Road, Unthank Road, Christchurch Road.

**IPSWICH ROAD** – from 15m south of its junction with Hornor Close for 30m northwards to facilitate Anglian Water new connection works between (i) 19:00 on 13th and 07:00 on 14th December 2023; (ii) 21:00 on 14th and 07:00 on 15th December 2023; and (iii) 19:00 on 15th and 07:00 on 16th December 2023 for the duration of the works, only while signs indicating the closure are in place. Alternative route is via: Ipswich Road, St Stephens Road, St Stephens Road, St Stephens Road, St Stephens Road, Lakenham Road.

**LINCOLN STREET –** from 81m north of its junction with Unthank Road for 48m north-westwards to facilitate new water connection works. Traffic using the road will be temporarily prohibited from parking, stopping and loading/unloading vehicles from 11th to 13th December 2023. Alternative route is N/A.

**RANDLE GREEN 1 (FOOTPATH)** – footpath Randle Green for its entirety to facilitate fibre network installation works from 14th to 18th December 2023. Alternative route is via: Randle Green Footpath From East Side Of 5 To West Side Of 36 Bates Green, Randle Green and vice versa.

ELECTRIC VEHICLE CHARGING POINT SCHEME (VARIOUS ROADS) - 1) Hall Road from its junction with Gordon Square for 20m northwards (30 minute parking bay); 2) Hobart Square from its junction with Hall Road for 25m eastwards (2 hours parking bay); 3) Mill Hill Road from a point opposite no.58 Mill Hill Road for 30m southwards (permit parking only); 4) Onley Street from its corner junction with Leicester Street for 15m northwards (eastern side only); 5) St Leonards Road from 30m north of its junction with Gas Hill for 16m northwards (western side only); and 6) Telegraph Lane East from 10m northwest of its junction with Ranson Road for 45m north westwards (western side only); to facilitate installation of electric vehicle charging point infrastructure. Traffic using the roads will be temporarily prohibited from parking, stopping and loading/unloading vehicles and the parking bays at the locations listed will be suspended from 11th to 24th December 2023 for the duration of the works only while signs indicating the suspension are in place. Alternative routes are N/A.

(ii) THEY HAVE MADE Temporary Traffic Regulation Orders in respect of the following roads:

**COTMAN ROAD and HEATHSIDE ROAD – 1) Cotman Road** from 60m east of its junction with Fern Hill Heathside Road for 40m eastwards; and **2) Heathside Road** from its junction with Cotman Road for 20m southwards to facilitate water connection works from 4<sup>th</sup> to 8<sup>th</sup> December 2023. Alternative route is via: Cotman Road, Thorpe Road, Carrow Road, Clarence Road, Telegraph Lane East (Thorpe St. Andrew).

**GLOUCESTER STREET -** from its junction with Unthank Road to its junction with Newmarket Street to facilitate lead comms replacement works from 4<sup>th</sup> December 2023 to 29<sup>th</sup> January 2024. Alternative route is via: Unthank Road, Bury Street, Newmarket Street.

**HELLESDON MILL LANE** - from its junction with Hellesdon Road for 135m westwards to facilitate fibre network installation works from 4<sup>th</sup> to 8<sup>th</sup> December 2023. Alternative route is via: Hellesdon Road, Hellesdon Mill Lane and vice versa.

ST LEONARDS ROAD AREA - 1) St Leonards Road from 50m west of its junction with Marion Road to 50m northeast of its junction with Beatrice Road; 2) Marion Road from its junction with St Leonards Road for 50m eastwards; 3) Florence Road from its junction with St Leonards Road for 50m eastwards; and 4) Beatrice Road from its junction with St Leonards Road for 50m eastwards; to facilitate drainage works. Traffic using the roads 1), 2), 3) and 4) will be temporarily prohibited from parking, stopping and loading/unloading vehicles from 4<sup>th</sup> to 6<sup>th</sup> December 2023. Alternative route is N/A.

Unless otherwise stated, the effect of these Orders will be to prohibit the use by vehicles of the named road(s). All other restrictions are included where necessary. In the event of the start date being delayed the new start date will be displayed on site in advance. Alternative routes are shown where applicable and pedestrian access will be maintained at all times. If necessary, the restrictions could run for a maximum period of 18 months from the date of the Orders or 6 months in respect of footpaths, cycle paths, bridleways, restricted byways, and byways open to all traffic (BOAT).

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
