

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257 AND
PARAGRAPH 8 OF SCHEDULE 14

NORWICH CITY COUNCIL
HALF MILE ROAD FOOTPATH BETWEEN 54 AND 56 TO GLENMORE GARDENS, (4F175/10)
(PART)
PUBLIC FOOTPATH DIVERSION ORDER 2022

The above Order was confirmed by Norwich City Council on **20th April 2022**.

The effect of the Order as confirmed is to divert the length and width of that part of Half Mile Road Footpath Between 54 and 56 to Glenmore Gardens (4F175/10) commencing at point A on the Order Map (grid reference: TG 21915 10636) and proceeding in a generally northerly direction for a distance of approximately 18 metres to point B on the Order Map (grid reference: TG 21921 10653) and then continuing in a generally easterly direction for a distance of 11 metres to point C on the attached map (grid reference: TG 21931 10650) and create an alternative footpath being 3 metres wide and commencing at point A on the Order Map (grid reference: TG 21915 10636) and continuing in a generally easterly direction for 13 metres to terminate where it meets Glenmore Gardens (U41420) at point D on the Order Map (grid reference: TG 21928 10637).

A copy of the Order and Order Map contained in it have been deposited at the offices of Norwich City Council, City Hall, St Peters Street, Norwich, NR2 1NH and may be seen at all reasonable hours by appointment only. This Order came into force on the date on which Norfolk County Council certified that the terms of Article 2 of the Order had been complied with but if any person aggrieved by the Order desires to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above Act, or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the Order, he or she may apply to the High Court for any of these purposes under section 287 of the Town and Country Planning Act 1990 within 6 weeks from the date on which notice is first published as required by paragraph 8 of Schedule 14 to that Act.

Certificate of order coming into force – in accordance with section 257 paragraph 8 of schedule 14 of the Town and Country Planning Act 1990, notice is hereby given that on 7th December 2023 Norfolk County Council certified that the replacement rights of way required under the terms of the above order have been created to its reasonable satisfaction.

The Order has now taken effect.
