## Norfolk County Council (Costessey and Norwich, Various Roads) Traffic Orders Notice 2023

The Norfolk County Council has made the following Orders under the Road Traffic Regulation Act, 1984, on 12<sup>th</sup> December 2023:-

## Norfolk County Council (Costessey, U78239 Richmond Road and A1074 Dereham Road) (Prohibition of Right Turn) Order 2023

This Order will come into operation on 16<sup>th</sup> December 2023 and the effect of which is to prohibit vehicles proceeding along the U78239 Richmond Road to make a right turn into the A1074 Dereham Road (except for emergency vehicles on emergency business).

## Norfolk County Council (Northern Area)(Prohibition and Restriction of Waiting) (Barnard Road and Robberds Way) Amendment Traffic Regulation Order 2023

This Order will come into operation on 22<sup>nd</sup> December 2023 and the effect of which is to amend the Norwich City Council Norwich (Northern Area) (Prohibition and Restriction of Waiting) (Consolidation) Order 1982 (as amended) to add to the current no waiting at any time restriction on the lengths of Barnard Road and Robberds Way as follows:-

- (i) U45104/10 Barnard Road (North side) extending the existing double yellow lines by 55 metres eastwards; and
- (ii) U45388/10 Robberds Way installing double yellow lines from a point 11 metres south of the centreline of its junction with U45104/10 Barnard Road, for a distance of 4 metres southwards.
