

**Norfolk County Council (Norwich, Angel Road and Rosebery Road)**  
**Emergency Notice**  
**Temporary Traffic Regulation Order 2024**  
**Section 14(2) of the Road Traffic Regulation Act 1984**

Norwich, Angel Road and Rosebery Road (CTRO1053) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to emergency gas main repairs the use by vehicles (of any class/specific class) of the Rosebery Road from its junction with Angel Road for 30m eastwards (the "Road A") and Angel Road from its junction with Rosebery Road for 30m northwards and 30m southwards ("the Road B") in the City of Norwich will be temporarily prohibited/restricted.

Alternative route is via: Rosebery Road, St Clements Hill, Chamberlin Road, Angel Road. Waterloo Road, Constitution Hill, Woodcock Road, Angel Road.

The closure/restriction is necessary because of the likelihood of danger to the public or serious damage to the road or both.

The closure/restriction is anticipated to take place from 9<sup>th</sup> to 11<sup>th</sup> September 2024 but the Road A and the Road B may continue to be closed/restricted until the 29<sup>th</sup> September 2024 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall automatically revoke on the completion of the works / when the closure/restriction is no longer necessary or otherwise on the 29<sup>th</sup> September 2024 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

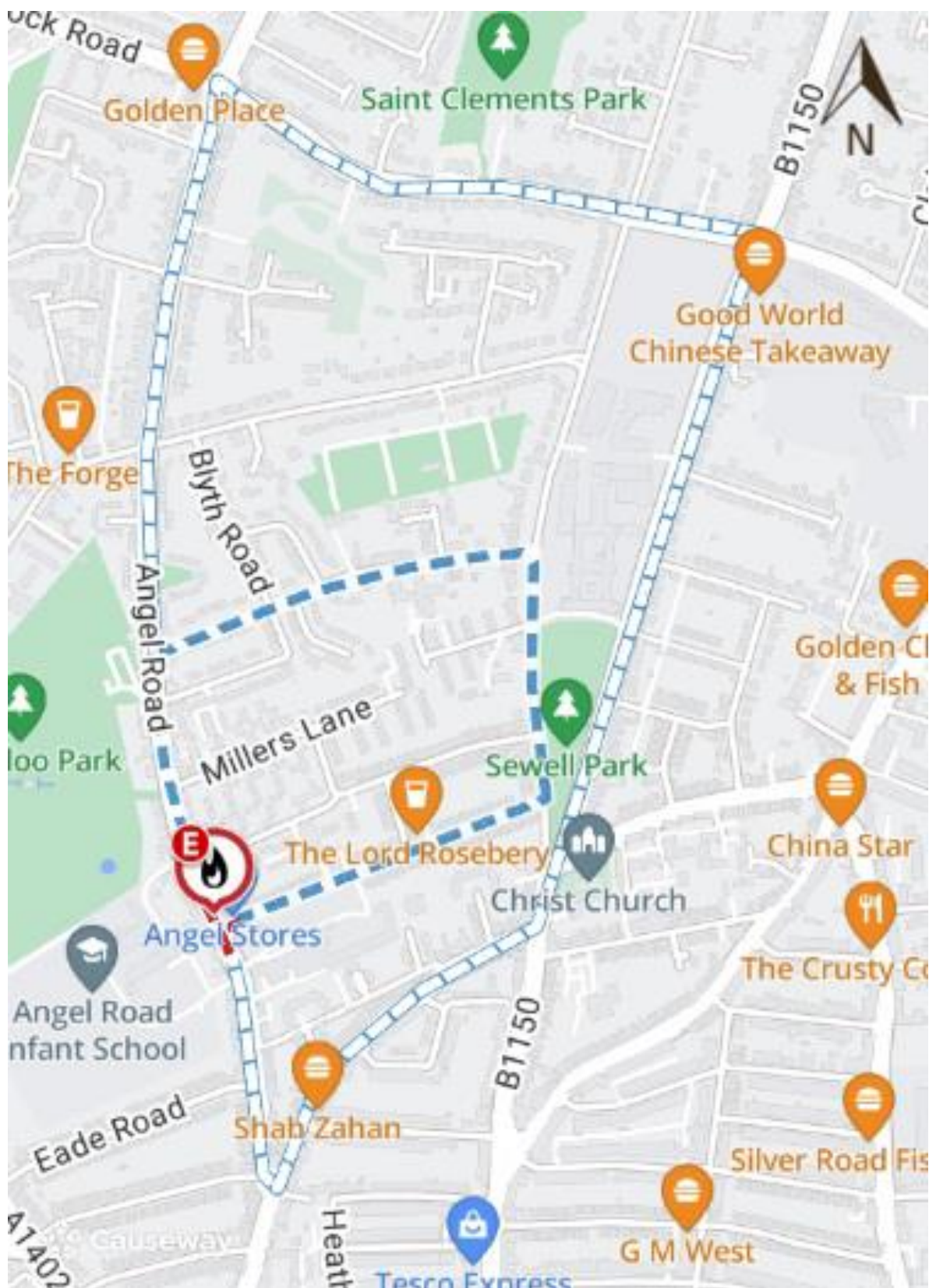
Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
