What you must do to comply with the law

As a guide, contraventions relating to cleaning, temperature control and poor practice, should be dealt with straight away.

Contraventions relating to structural repairs, your food safety management system and staff training, should be completed within the next 2 months.

Health and safety contraventions should be dealt with within 3 months unless otherwise stated.

To assist you the report may also include **Observations** of current practice, useful **Information, Recommendations** of good practice and reminders of **Legal Requirements**.

My inspection was not intended to identify every contravention of the law and only covers those areas, practices and procedures examined at the time of the inspection. If the report fails to mention a particular matter this does not mean you have necessarily complied with the law.

1. Food Hygiene and Safety

Food Hygiene standards are excellent. You demonstrated full compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. **(0)**

2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. **(5)**

Cleaning of Structure

Contravention The following items were dirty and require more frequent and thorough cleaning:

- the walls and ceiling in the back-of-house area were dirty, with cobwebs present

3. Confidence in Management

There are generally satisfactory food safety controls in place although there is evidence of some non-compliance with the law. The contraventions require your attention; although not critical to food safety they may become so if not addressed. **(10)**

Type of Food Safety Management System Required

Contravention As a low-risk food business, you are still required to have a suitable food safety management system in place. The system currently in place is either absent or does not adequately reflect the food safety risks associated with your business.

A minimum level of documented procedures and records should be maintained. Depending on the nature of your business, these may include:

- hygiene rules and procedures
- pest control records/reports
- staff illness and exclusion policy
- cleaning schedule and records
- date coding procedures
- temperature checks of display chillers
- hand over diary or communication records
- any other documentation necessary to demonstrate that food safety risks are being adequately controlled

Traceability

Observation Your records were such that food could easily be traced back to its supplier.
