Those items which relate to structural repairs, training and the provision/review of your food safety management system should be completed with within the next <u>2 months</u>.

Health and safety contraventions should be dealt with within <u>3 months</u> unless otherwise indicated. Urgent matters must be dealt with <u>straight away</u>.
