Health and safety contraventions should be dealt with within 3 months unless otherwise indicated. Urgent matters must be dealt with straight away.

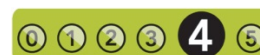

### General description of the business

### Food Hygiene

#### Summary:

Food hygiene standards are excellent. You demonstrated full compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. **(Score 0)**

#### Hand-washing

1. I was pleased to see that there was hot water, soap and hand drying facilities in the customers toilets. **(Observation):**

#### Temperature Control

2. I was pleased to see that :- **(Observation)**
  - The fridge that the milk is stored in was running at correct temperatures.
  - The cellar was running at the correct temperature.

### Structure and Cleaning

#### Summary:

The structure, facilities, cleaning and maintenance are of a generally satisfactory standard but there are some repairs and/or improvements which are required in order for you to comply with the law. Pest control and waste disposal provisions are adequate. The contraventions require your attention; although not critical to food safety they may become so if not addressed. **(Score 10)**

#### Cleaning

3. The following items were dirty and require more frequent and thorough cleaning. **(Contravention):**
  - Condensational mould to the cellar ceiling and walls where the cooler is sited.
  - Cobwebs were seen to the walls in the cellar.
  - Beer cooler.
4. I was pleased to see that :- **(Observation)**
  - The beer lines were cleaned regularly.
  - Generally the premises was kept in a clean condition.

### Maintenance

5. The following items/areas had not been maintained in good repair and condition.  
**(Contravention):**

- Some damage to the cellar floor.

### **Confidence in Management**

#### **Summary:**

There are generally satisfactory food safety controls in place although there is evidence of some non-compliance with the law. The contraventions require your attention; although not critical to food safety they may become so if not addressed. **(Score 10)**

#### **Documented Food Safety Management System**

6. There were no written procedures in place. Your business is low risk and so your written procedures need not be elaborate. However, there must be some documentation and would suggest; rules of hygiene (including how and when staff wash their hands and your exclusion policy); cleaning schedule; date coding; pest reports. **(Contravention)**

#### **Allergies**

7. New legislation requires food businesses to provide allergy information on unpackaged food sold from all catering outlets including takeaways, deli counters, bakeries and sandwich bars etc. The potential for cross contamination by allergens must also be made known to consumers.
