1. Food Hygiene and Safety

Food Hygiene standards are excellent. You demonstrated full compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. **(Score 0)**

Observation - All stored seen to be stored appropriately. Good knowledge of food allergens observed.

2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all excellent and you demonstrated full compliance with the law. There is evidence of effective pest control and procedures are in place to rectify any problems as they arise. There is good provision for waste disposal. **(Score 0)**

Observation - Well appointed market stall with newly fitted kitchen and cookware. Main cooker not presently in use until finishing touches (cosmetic) have been addressed. Currently the only hot food being served is paninis with a variety of fillings made on the

premises. Correct sanitisers being used conforming with BS EN standards

3. Confidence in Management

A food safety management system is in place and you comply fully with the law. Hazards to food are understood properly controlled managed and reviewed. Your records are appropriate and being maintained. All your staff are suitably supervised and trained. You have a very good track record. **(Score 0)**

Observation - SFBB in use and satisfactorily completed, with daily checks being undertaken as well as temperature recording. Advised to disregard sections of SFBB not relevant to the business. FBO expressed an interest in food hygiene courses, a link to which has been provided in a separate email, following the inspection.
