How we calculate your Food Hygiene Rating:

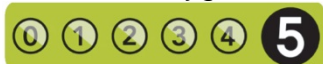

1. Food Hygiene and Safety

Food hygiene standards are high. You demonstrated a very good standard of compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. Some minor contraventions require your attention. **(Score 5)**

Hand-washing

Observation Hand washing was managed well and wash-hand basins were well stocked with hand cleaning material. Sanitising gel was provided for all persons entering the kitchen through the main access door.

Temperature Control

Observation I was pleased to see you were able to limit bacterial growth and/or survival by applying appropriate temperature controls at points critical to food safety and that you were diligently monitoring temperatures.

Poor Practices

Observation I was pleased to note that the ingredients for the community lunch are purchased on the day for use on the day and any information on the labels on these foods is retained.

2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. **(Score 5)**

Cleaning of Structure

Observation I was pleased to see that all the surface finishes were easy to clean and kept clean.

Observation Remember to include a high level clean for the tops of cupboards, light fittings, on your cleaning rota.

Maintenance

Observation I was pleased to see that the kitchen facilities had been refurbished to a high standard.

3. Confidence in Management

A food safety management system is in place and you demonstrate a very good standard of compliance with the law. Food hazards are understood properly controlled managed and reviewed. Your records are appropriate and generally maintained. Your volunteers are suitably supervised and trained. There are some minor contraventions which require your attention. **(Score 5)**
