1. Food Hygiene and Safety

Food hygiene standards are high. You demonstrated a very good standard of compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. Some minor contraventions require your attention. **(Score 5)**

Contamination risks

Observation Wet pub only selling pre-packed bags of crisps and pickled eggs

Hand-washing

Observation Hand washing was managed well and wash-hand basins were well stocked with hand cleaning material.

Unfit food

Observation I was pleased to stock e.g. crisps are rotated

2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. **(Score 5)**

Cleaning of Structure

Contravention The following structural items were dirty and require more frequent and thorough cleaning:

- the floor behind the bar between equipment fixtures
- bits of rubbish in the area where beer deliveries arrive in the cellar
- ceiling in the cellar next to the fan mouldy

Cleaning Chemicals / Materials / Equipment and Methods

Observation I was pleased to see that the premises was kept clean and that your cleaning materials, methods and equipment were able to minimise the spread of harmful bacteria between surfaces.

Maintenance

Contravention The following items had not been suitably maintained and must be repaired or replaced:

- glass washer broken. I note this was in the process of being replaced and temporary arrangements to hand wash glass ware is being carried out.

3. Confidence in Management

A food safety management system is in place and you demonstrate a very good standard of compliance with the law. Your staff are suitably supervised and trained. You have a good track record. **(Score 5)**

Infection Control / Sickness / Exclusion Policy

Guidance Public Health England recommends that food handlers known or suspected to be suffering from a food-borne infection or gastro-intestinal illness stay away from work until symptom-free for 48 hours.
