1. Food Hygiene and Safety

Personal Hygiene

Observation I was pleased to see that standards of personal hygiene were high.

Temperature Control

Observation The ham in the dish in the bench top service unit was higher than 8 degrees Celsius whereas the other dishes appeared to be in temperature control, monitor this to ensure foods are kept within the cold chain - or only kept outside for short periods of time;

2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. **(Score 5)**

Cleaning of Structure

Contravention The following structural items were dirty and require more frequent and thorough cleaning:

- silicon seals behind sink becoming mouldy

Observation The kitchen had been well maintained and the standard of cleaning was exceptionally high.

Cleaning Chemicals / Materials / Equipment and Methods

Observation I was pleased to see that the premises was kept clean and that your cleaning materials, methods and equipment were able to minimise the spread of harmful bacteria between surfaces.

3. Confidence in Management

A food safety management system is in place and you comply fully with the law. Hazards to food are understood properly controlled managed and reviewed. Your records are appropriate and being maintained. All your staff are suitably supervised and trained. You have a very good track record. **(Score 0)**
