## **1. Food Hygiene and Safety**

## **2. Structure and Cleaning**

The structure facilities and standard of cleaning and maintenance are all excellent and you demonstrated full compliance with the law. There is evidence of effective pest control and procedures are in place to rectify any problems as they arise. There is good provision for waste disposal. **(Score 0)**

### Cleaning Chemicals / Materials / Equipment and Methods

**Observation** I was pleased to see that the mobile unit was kept clean and that your cleaning materials, methods and equipment were able to minimise the spread of harmful bacteria between surfaces. You had a comprehensive supply of cleaning materials.

### Maintenance

**Observation** I was pleased to see the kitchen had recently been refurbished.

## **3. Confidence in Management**

A food safety management system is in place and you comply fully with the law. Hazards to food are understood properly controlled managed and reviewed. Your records are appropriate and being maintained. All your staff are suitably supervised and trained. You have a very good track record. **(Score 0)**

You had been taking regular temperatures of fridges and freezers (when operating), you have a food probe and sanitising wipes and I was confident that your operating procedures were satisfactory and would be continued once you were operating again.
