1. Food Hygiene and Safety

Observation I was pleased to see that you had dedicated work surfaces/areas for different food preparation i.e raw meat

I was pleased to see that you have procedures in place to ensure the safety of the food you serve and these are being followed by all staff. Staff exhibit good personal hygiene, food is protected from risk of contamination and is handled and served correctly.

2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. **(Score 5)**

Cleaning Chemicals / Materials / Equipment and Methods

Observation I was pleased to see that the premises was kept clean and that your cleaning materials, methods and equipment were able to minimise the spread of harmful bacteria between surfaces.

Maintenance

Contravention The following items had not been suitably maintained and must be repaired or replaced:

- sealant to sink unit in desert room
- broken door seal to white fridge in desert room
- open jointed patches to altro type flooring in desert room
- leaking hose/tap to sink in desert room
- broken hinges to freezer in storeroom
- bar top

It was noted that some of the above are already in hand with their repair/replacement already programmed.

Facilities and Structural provision

Contravention Ventilation was inadequate in the following areas:

- the toilet accommodation

3. Confidence in Management

A food safety management system is in place and you comply fully with the law. Hazards to food are understood properly controlled managed and reviewed.
