1. Food Hygiene and Safety

Food hygiene standards are high. You demonstrated a very good standard of compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. Some minor contraventions require your attention. (Score 5)

Observation: It was noted that contamination issues were controlled and foods (ingredients for cocktails) were held in appropriate conditions

2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. (Score 5)

Observation: The premises were well maintained and a high standard of cleanliness was observed

3. Confidence in Management

A food safety management system is in place and you demonstrate a very good standard of compliance with the law. Food hazards are understood properly controlled managed and reviewed. Your records are appropriate and generally maintained. Your staff are suitably supervised and trained. You have a good track record. There are some minor contraventions which require your attention. (Score 5)

Proving Your Arrangements are Working Well

Observation It was noted that you use dried citrus fruits in your cocktails that are produced locally for you. Your containers had not been dated/labelled. It was noted that the batch is small and is used relatively quickly ensuring freshness of the product.

Recommendation Labelling perishable food with the date is must be used or discarded will help you rotate your stock and demonstrates you have effective controls in place. With regards to the dried citrus fruits it is recommended that the date the batch was received by you is written on the container.
