2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. **(Score 5)**

Contravention It was noted that the staff WC room was dirty. Ensure that you thoroughly clean the floor, wall surfaces, wash hand basins and WC pan, and keep it in a clean condition.
