### 1. Food Hygiene and Safety

Food hygiene standards are high. You demonstrated a very good standard of compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. Some minor contraventions require your attention. (**Score 5**)

### Hand-washing

**Contravention** The following indicated that hand-washing was not suitably managed:

- Wash hand basins were dirty
- An equipment sink was used to wash hands (although wash hand basins were available)

## **Temperature Control**

**Observation** I was pleased to see you were able to limit bacterial growth and/or survival by applying appropriate temperature controls at points critical to food safety and that you were monitoring temperatures.

# 2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. (Score 5)

### Cleaning of Structure

**Contravention** The following items were dirty and require more frequent and thorough cleaning:

- High level cleaning in stock room
- The floor in the stock room was very greasy and dirty in corners and underneath the shelf units

#### Maintenance

**Contravention** The following had not been suitably maintained and must be repaired or replaced:

- Broken doors
- Cold tap to the sink
- General maintenance of the walls in the corridor

### 3. Confidence in Management

A food safety management system is in place and you demonstrate a very good standard of compliance with the law. Food hazards are understood properly controlled managed and reviewed. Your records are appropriate and generally maintained. Your staff are suitably supervised and trained. You have a good track record. (Score 5)

**Observation** Your SFBB/food safety management system was in place and working well. I was confident you had effective control over hazards to food.

## Proving Your Arrangements are Working Well

**Contravention** The following matters are needed in order to demonstrate your food safety management system is working as it should:

- Review your cleaning schedule to ensure areas are not missed.
- Improve recording and reporting of maintenance issues.
