### 1. Food Hygiene and Safety

Food Hygiene standards are excellent. You demonstrated full compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. (Score 0)

### **Temperature Control**

**Observation** I was pleased to see you were able to limit bacterial growth and/or survival by applying appropriate temperature controls at points critical to food safety and that you were monitoring temperatures.

### 2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. (Score 5)

Contravention Sanitiser not dated and staff not clear how long it should be kept for.

## 3. Confidence in Management

A food safety management system is in place and you demonstrate a very good standard of compliance with the law. Your records are appropriate and generally maintained. You have a good track record. There are some minor contraventions which require your attention. (Score 5)

## Type of Food Safety Management System Required

**Observation** The documented food safety management system was not reviewed as Primary Authority advice has been issued.

### **Traceability**

**Observation** Your records were such that food could easily be traced back to its supplier.

#### **Training**

**Contravention** The following evidence indicates there is a staff training need as food handlers:

- Confusion as to dating of prepared sanitiser and how long it should be kept for.
- Staff not clear where to refer to for allergen information.
