### 1. Food Hygiene and Safety

You have a good track record. There are some minor contraventions which require your attention. **(Score 5)**

#### Contamination risks

**Contravention** The following exposed food to the general risk of cross-contamination with bacteria or allergens or its physical contamination with dirt or foreign objects:

- loose/flaking plasterwork above vacuum packer.

### 2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. **(Score 5)**

#### Maintenance

**Contravention** The following had not been suitably maintained and must be repaired or replaced:

- Damage to ceiling above area where vacuum packer is used. This was later attended to expeditely and new plaster and paintwork undertaken to rectify the damage.

### Pest Control

**Contravention** Pest proofing is inadequate particularly in the following areas::

- no fly screens to the exterior window in main kitchen

**Information** I was pleased to note you ordered new fly screens when this was brought to your attention

### **3. Confidence in Management**

A food safety management system is in place and you demonstrate a very good standard of compliance with the law. You have a good track record. There are some minor contraventions which require your attention. Your records are appropriate and generally maintained. Your staff are suitably supervised and trained. You have a good track record. ### Food Hazard Identification and Control

**Contravention** Your food safety management system is not adequate in its scope and/or is not sufficiently detailed. Ensure your food safety management system is regularly reviewed, covers all of your food handling operations and that the controls in place at points critical to food safety are fully documented, monitored and verifiable. In particular address the following matters:

- you were in process of updating your vacuum packing procedure on the day of my inspection.

**Information** I was later supplied with an electronic version of the revised vacuum packing procedure and training programme.
