# 1. Food Hygiene and Safety

Food Hygiene standards are excellent. You demonstrated full compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. (Score 0)

# 2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. (Score 5)

#### Maintenance

**Contravention** The following had not been suitably maintained and must be repaired or replaced:

• the premises has recently undergone a major refurbishment/conversion to a new design of supermarket under the Tesco chain The new design incorporates exposed metal duct work, trunking and concrete block work and new plasterwork to walls in both the main shop and rear food storage warehouse area. At the time of my inspection some structures/areas still required works to ensure they are sound, non absorbent and easily cleanable. I acknowledge no open foods were being handled/stored in these areas. However, any rooms where food is stored or handled must be maintained, sound and easily cleanable.

**Information** I was pleased to note that you informed me that you are in contact with Tesco and its contractors to attend to some of the above issues and other 'snagging' matters that you have identified.

# Pest Control

**Observation** I was pleased to see that the premises was proofed against the entry of pests and that pest control procedures were in place.

# 3. Confidence in Management

A food safety management system is in place and you comply fully with the law. Hazards to food are understood properly controlled managed and reviewed. Your records are appropriate and being maintained. All your staff are suitably supervised and trained. You have a very good track record. (Score 0)

# Type of Food Safety Management System Required

**Observation** Your SFBB/food safety management system was in place and working well. I was confident you had effective control over hazards to food.
