# 1. Food Hygiene and Safety

Food hygiene standards are high. You demonstrated a very good standard of compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. Some minor contraventions require your attention. **(Score 5)**

**Contravention** The following indicated that hand-washing was not suitably managed:

• the wash hand basin in main kitchen was obstructed

# 2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste

disposal provisions are adequate. The minor contraventions require your attention. **(Score 5)** 

### Facilities and Structural provision

Contravention The following facilities were inadequate and must be improved:

 no toilet lobby or inadequate toilet ventilation. This is to help prevent odours and smells tainting open foods nearby or in food rooms. I acknowledge at present there is a wall that separates the main kitchen which help reduce the risk of this happening.

**Information/Recommendation** You have a limited sized kitchen and food handling space. No open or drink food must be handled near the entrance/lobby area to the w.c. cubicle. You informed me that you will comply with this instruction.

Guidance Consider installing a self closure door mechanism to the toilet door.

### 3. Confidence in Management

A food safety management system is in place and you comply fully with the law. Hazards to food are understood properly controlled managed and reviewed. Your records are appropriate and being maintained. All your staff are suitably supervised and trained. You have a very good track record. (Score 0)

### Type of Food Safety Management System Required

**Observation** Your SFBB/food safety management system was in place and working well. I was confident you had effective control over hazards to food.

**Observation** You were date labelling perishable foods appropriately and could demonstrate effective control over food spoilage organisms.

**Observation** You had colour-coded equipment and effective separation between raw and ready-to-eat food at all stages in your operation.

**Observation** You were monitoring (and recording) the temperatures of your fridges and freezers well as the temperature of cooked/hot-held food and could demonstrate effective systems for controlling bacterial growth and survival.

#### **Traceability**

**Observation** Your records were such that food could easily be traced back to its supplier.

#### Allergens

**Observation** You had identified the presence of allergens in your non-prepacked food and had brought this to the attention of your customers.

**Observation** You had clearly shown the presence of allergens in your food on your menu.

**Observation** You had devised a chart listing all the food you provide with the allergens present in each and had brought this to the attention of your staff and customers.
