### 1. Food Hygiene and Safety

Food Hygiene standards are excellent. You demonstrated full compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. **(Score 0)**

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. **(Score 5)**

### **3. Confidence in Management**

A food safety management system is in place and you demonstrate a very good standard of compliance with the law. You have a good track record. There are some minor contraventions which require your attention. **(Score 5)**

#### **Type of Food Safety Management System Required**

**Observation** You are a low risk business and do not have a food safety management system.

**Contravention** Despite being very low risk, you should still have to hand a minimum amount of documentation. For instance, this might include your hygiene rules; pest control reports; a staff illness and exclusion policy; a cleaning schedule; records of any checks you make for expired food items on your shelves and; a hand-over diary.
