# 1. Food Hygiene and Safety

Food hygiene standards are high. You demonstrated a very good standard of compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. Some minor contraventions require your attention. (Score 5)

# Contamination risks

**Observation** I was pleased to see you were able to demonstrate effective controls to prevent cross-contamination.

# Hand-washing

**Contravention** The following indicated that hand-washing was not suitably managed:

• The wash hand basin located in the wash up room was obstructed. I recommend that you relocate the mops, buckets and brooms to a separate location so as not to obstruct the wash hand basin.

**Observation** At the start of my visit, I noted that there was no hot water supply to the wash hand basin. I was pleased to see that this was quickly rectified following contact with your contractor, who was able to carry out the required work to re-instate hot water supply.

# Personal Hygiene

**Observation** I was pleased to see that standards of personal hygiene were high.

# Temperature Control

**Observation** I was pleased to see you were able to limit bacterial growth and/or survival by applying appropriate temperature controls at points critical to food safety and that you were monitoring temperatures.

# 2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. (Score 5)

## Cleaning of Structure

**Contravention** The following items were dirty and require more frequent and thorough cleaning:

 Dirt and mould growth noted on the cooling fan and ceiling covering located in the beer store.

#### Cleaning of Equipment and Food Contact Surfaces

**Recommendation** Remove the plastic film covering to the glass-wash machine in order to allow the machine to be thoroughly cleaned and where necessary disinfected.

#### Cleaning Chemicals / Materials / Equipment and Methods

**Observation** I was pleased to see that the premises was kept clean and that your cleaning materials, methods and equipment were able to minimise the spread of harmful bacteria between surfaces.

# Maintenance

**Contravention** The following had not been suitably maintained and must be repaired or replaced:

- Part of the wall surface in the beer store was in poor condition. Renew or repair the wall covering and leave in a sound easy clean condition.
- Seals to the undercounter fridges were in poor condition. Renew the door seals.

# Facilities and Structural provision

**Observation** I was pleased to see the premises had been well maintained and that adequate facilities had been provided.

# **Pest Control**

**Observation** You have a pest control contract in place and there is no evidence of pest activity on the premises.

# 3. Confidence in Management

A food safety management system is in place, and you demonstrate a very good standard of compliance with the law. Your staff are suitably supervised and trained. Your records are appropriate and generally maintained. You have a good track record. There are some minor contraventions which require your attention. (Score 5)

#### Type of Food Safety Management System Required

**Observation** Your SFBB/food safety management system was in place and working well. I was confident you had effective control over hazards to food.

**Observation** You were date labelling perishable foods appropriately and could demonstrate effective control over food spoilage organisms.

**Observation** You had colour-coded equipment and effective separation between raw and ready-to-eat food at all stages in your operation.

**Observation** You were monitoring (and recording) the temperatures of your fridges and freezers well as the temperature of cooked/hot-held food and could demonstrate effective systems for controlling bacterial growth and survival.

#### Food Hazard Identification and Control

**Contravention** The following pre-requisites have not been met and this means that your food safety management system will be ineffective:

• Maintenance is poor.

# **Traceability**

**Observation** Your records were such that food could easily be traced back to its supplier.

#### Infection Control / Sickness / Exclusion Policy

**Observation** Policies were in place to prevent any infected food handler from contaminating food.

# Waste Food and other Refuse

**Observation** You had measures in place to dispose of waste food appropriately and were employing the services of an approved waste contractor.

# Training

**Observation** I was pleased to see that food handlers had been trained to an appropriate level and evidence of their training was made available.

# Allergens

**Observation** You had identified the presence of allergens in your non-prepacked food and had brought this to the attention of your customers.

**Observation** You had clearly shown the presence of allergens in your food on your menu.

**Observation** You had devised a chart listing all the food you provide with the allergens present in each and had brought this to the attention of your staff and customers.
