## 1. Food Hygiene and Safety

#### Hand-washing

Observation I was pleased to see handwashing was well managed.

## Personal Hygiene

**Recommendation** I was pleased to see a good understanding of personal hygiene procedures regarding handling of open food

## Temperature Control

**Observation** I was pleased to see you were able to limit bacterial growth and/or survival by applying appropriate temperature controls at points critical to food safety and that you were monitoring temperatures.

## 2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all excellent and you demonstrated full compliance with the law. There is evidence of effective pest control and procedures are in place to rectify any problems as they arise. There is good provision for waste disposal. **(Score 0)** 

#### Cleaning of Structure

**Observation** The kitchen had been well maintained and the standard of cleaning was exceptionally high.

**Recommendation** Minor inert debris was found to rear of chest freezer. I would recommend the frequency of cleaning be increased in this area.

#### Maintenance

**Observation** You are maintaining the premises in good condition.

#### Facilities and Structural provision

**Observation** I was pleased to see the premises had been well maintained and that adequate facilities had been provided.

#### 3. Confidence in Management

A food safety management system is in place and you comply fully with the law. Hazards to food are understood properly controlled managed and reviewed. Your records are appropriate and being maintained. All your staff are suitably supervised and trained. You have a very good track record. **(Score 0)** 

#### Type of Food Safety Management System Required

**Observation** You were monitoring (and recording) the temperatures of your fridges and freezers as well as the temperature of cooked/hot-held food and could demonstrate effective systems for controlling bacterial growth and survival.

**Observation** Your SFBB/food safety management system was in place and working well. I was confident you had effective control over hazards to food.

## **Traceability**

**Observation** Your records were such that food could easily be traced back to its supplier.

## <u>Training</u>

**Observation** I was pleased to see that food handlers had been trained to an appropriate level and evidence of their training was made available.

## <u>Allergens</u>

Recommendation You are advised to provide written information,

1. asking customers to inform staff members about allergies or food intolerances that they may have

2. warning customers that the absence of traces of allergens cannot be guaranteed because food prepared by gand in an open kitchen
