My inspection was not intended to identify every contravention of the law and only covers those areas, practices and procedures examined at the time of the inspection. If the report fails to mention a particular matter this does not mean you have necessarily complied with the law.

1. Food Hygiene and Safety

Food hygiene standards are high. You demonstrated a very good standard of compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. Some minor contraventions require your attention. (Score 5)

Personal Hygiene

Observation I was pleased to see that standards of personal hygiene were high.

Temperature Control

Information:

• Two freezers were seen to be due defrosting with build up of ice beyond recommended limit.

Unfit food

Information:

- Bent canned food taken off display in my presence.
- Canned drinks/food stored on floor and also under shelving this was mentioned at the last inspection.
- Food past its Use by date is recorded in a book and then disposed of.

2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all of a good standard and only minor repairs and/or improvements are required. Pest control and waste disposal provisions are adequate. The minor contraventions require your attention. (Score 5)

Cleaning Chemicals / Materials / Equipment and Methods

Observation I was pleased to see that the premises was kept clean and that your cleaning materials, methods and equipment were able to minimise the spread of harmful bacteria between surfaces.

<u>Maintenance</u>

Contravention Holes in ceiling - round holes look like CCTV cameras were removed and large hole due to water leak from property above - this is to be rectified once the leak has been addressed to the above property - work is ongoing.

3. Confidence in Management

A food safety management system is in place and you demonstrate a very good standard of compliance with the law. You have a good track record. There are some minor contraventions which require your attention. **(Score 5)**

Information Some issues identified in the last inspection are still outstanding, however, you have moved forward in having a better food management system in place, which is working well.
