1. Food Hygiene and Safety

Food hygiene standards are high. You demonstrated a very good standard of compliance with legal requirements. You have safe food handling practices and procedures and all the necessary control measures to prevent cross-contamination are in place. Some minor contraventions require your attention. **(Score 5)**

Contamination risks

Contravention The following exposed food to the general risk of cross:

- contamination with bacteria or allergens or its physical contamination with dirt, foreign objects or chemicals

Observation - Scoop and ice scoop were stored with food product and with the ice.

Recommendation - Ensure scoops are kept safe inside a dry lidded container when not in use.

Personal Hygiene

Observation - I was pleased to see that standards of personal hygiene were high.

Temperature Control

Observation - I was pleased to see you were able to limit bacterial growth and/or survival by applying appropriate temperature controls at points critical to food safety and that you were monitoring temperatures.

2. Structure and Cleaning

The structure facilities and standard of cleaning and maintenance are all excellent and you demonstrated full compliance with the law. There is evidence of effective pest control and procedures are in place to rectify any problems as they arise. There is good provision for waste disposal. **(Score 0)**

3. Confidence in Management

A food safety management system is in place and you comply fully with the law. Hazards to food are understood properly controlled managed and reviewed. Your records are appropriate and being maintained. All your staff are suitably supervised and trained. You have a very good track record. **(Score 0)**

HEALTH, SAFETY AND WELFARE

Observation - Paper disposables had been stored on top of the oven.

Recommendation - Ensure all paper disposables are stored safely away from any fire hazard. The top of the oven was hot during today's inspection which could become a potential fire hazard.
