## **Broadland District Council / South Norfolk Council / Norwich City Council**

Hereby gives notice of its decision not to undertake a Strategic Environmental Assessment (SEA) nor Habitat Regulation Assessment (HRA) for the Draft GNLP Policy 2: Sustainable Communities Supplementary Planning Document (SPD) on the basis that the parent policy GNLP 2 has been subject to SEA and HRA.

The Draft GNLP Policy 2: Sustainable Communities (SPD) is not likely to cause significant environmental effects. This determination is based on the (SEA) criteria for determining the likely significance of effects on the environment as part of screening report. In addition, it will not have an effect on protected Habitats sites either alone, or in combination with other plans or projects based on the HRA criteria.

The decision has been taken by the Place Shaping Manager following consideration of a detailed screening report and has been subject to formal consultation with the Environment Agency, English Heritage, and Natural England. Members of the public wishing to find out more should contact:

#### 1. Introduction

- 1.1 The GNLP Policy 2: Sustainable Communities Supplementary Planning Document (SPD) (draft) has been produced by Broadland District Council, Norwich City Council and South Norfolk Council. The SPD will apply to the whole of the Broadland District, Norwich and South Norfolk Council areas, excluding the Broads National Park, for which the Broads Authority is the local planning authority.
- 1.2 The purpose of the GNLP Policy 2 SPD is to provide detailed guidance to applicants and planners on how to address the ten key social, economic and environmental issues outlined in Policy 2. By doing so, it ensures that new developments contribute to the creation of sustainable communities across the Broadland, Norwich and South Norfolk Council area.
- 1.3 This screening report reviews the GNLP Policy 2: Sustainable Communities (SPD) (draft) and is designed to test whether or not the contents of the draft SPD require:
  - (a) a full Strategic Environmental Assessment (SEA). The legislative background to SEA is set out in Section 2 of this report and Section 5 provides a screening assessment of the likely significant effects of the SPD and whether there is need for a full SEA.
  - (b) a full Habitats Regulation Assessment (HRA). The legislative background to HRA is set out in Section 3 of this report and Section 5 provides a screening assessment to highlight if there are any risks of the SPD having a significant effect on protected Habitat sites, either on its own or in combination with other proposals. ### 2. The need for Strategic Environmental Assessment (SEA) Screening

- 2.1 Paragraph 008 of the <u>Planning Practice Guidance: Strategic environmental</u>
  <u>Assessment and sustainability appraisal</u> states that 'Supplementary planning documents do not require a sustainability appraisal but may in exceptional circumstances require a strategic environmental assessment if they are likely to have significant environmental effects that have not already have been assessed during the preparation of the relevant strategic policies.
- 2.2 A strategic environmental assessment is unlikely to be required where a supplementary planning document deals only with a small area at a local level (see regulation 5(6) of the Environmental Assessment of Plans and Programmes Regulations 2004), unless it is considered that there are likely to be significant environmental effects.
- 2.3 Before deciding whether significant environment effects are likely, the local planning authority will need to take into account the criteria specified in <u>schedule 1</u> to the Environmental Assessment of Plans and Programmes Regulations 2004 and consult the consultation bodies'.
- 2.4 Therefore, the purpose of this document is to screen the GNLP Policy 2: Sustainable Communities (SPD) (draft) to determine whether there are likely to be any significant environmental effects, which would require an SEA. The three consultation bodies (Historic England, Environment Agency and Natural England) will be consulted to determine whether they agree with the conclusions of this report.

# 3. The need for Habitats and Species Regulation (HRA) Screening

- 3.1 The requirement to undertake Habitats Regulation Assessment (HRA) of plans and projects is set out in the Conservation of Habitats and Species Regulations (2017) (as amended). Regulation 105 of the Habitats Regulations requires consideration to be given to whether a plan will have an effect on protected habitats sites either alone, or in combination with other plans or projects. As per the Habitat regulations assessment guidance the process can have up to 3 stages: the first of which is screening to check if the proposal is likely to have a significant effect on the site's conservation objectives. If no significant effect is identified there is no need to go through the subsequent stages of Appropriate Assessment or Derogation. The GNLP was subject to full Habitat Regulations Assessment. Where screening identified a likely significant effect, Appropriate Assessment was undertaken and the mitigation measures identified were incorporated within the plan, resulting in the conclusion that the GNLP would not lead to any adverse effects on habitat sites within the Greater Norwich area.
- 3.2 Therefore, the purpose of this document is to screen the **Policy 2: Sustainable Communities SPD** (Draft) to ensure that it will not lead to any adverse effects on protected Habitats sites not already identified and mitigated for by the wider GNLP HRA.







### 4. Policy Context

- 4.1 The Sustainable Communities SPD, once adopted, will be supplementary to GNLP Policy 2: Sustainable Communities.
- 4.2 Policy 2 of the GNLP sets out ten key requirements that enable sustainable communities. These include ensuring access to services and facilities, integrating new technologies, providing green infrastructure, applying appropriate densities, incorporating good design, promoting resilient safe inclusive communities, ensuring environmental protection, preventing flood risk, ensuring water efficiency measures, and promoting low carbon development.
- 4.3 Major developments are required through policy 2 to submit a Sustainability Statement to show, on a site-by-site basis, how the varied aspects of policy 2 are addressed. This draft SPD outlines what the Sustainability Statements must cover to meet the policy requirements, the information expected to be provided as part of planning applications, and points to useful sources of information and best practice examples where appropriate. It will also be helpful in providing guidance on how non-major developments can meet policy requirements. In addition, the SPD provides guidance regarding the submission of Health Impact Assessments, Delivery Plans and master-planning as required by policy 2.
- 4.4 The SPD will assist landowners, developers and applicants to check all the requirements for new development are met and should help applicants demonstrate how proposals are policy compliant. Well written Sustainability Statement will assist decision makers and may help speed up the planning application process.

# 5. Methodology

#### Sustainability Appraisal Methodology

5.1 The SPD is supplementary to policy 2 of the GNLP which has undergone full Sustainability Appraisal. Therefore, there is no need to further assess this policy against the SA Objectives.

#### Strategic Environmental Assessment – Regulatory Requirements

- 5.2 To assess whether an SEA is required the local authority must undertake a screening process based on a standard set of criteria. This screening must be subject to consultation with Historic England, the Environment Agency and Natural England. Following consultation, the results of the screening process must be detailed in a Screening Statement, which is required to be made available to the public.
- 5.3 Using the criteria, detailed in <u>Schedule 1 of the Environmental Assessment of plans</u> and <u>Programmes Regulations 2004</u>, for determining the likely significance of effects on the environment, the following assessments have been made in Tables 1 and 2.

## **HRA Screening Assessment**

To assess whether an Appropriate Assessment as a part of the HRA is required the local authority must undertake a screening process based on a standard set of criteria. This must be subject to consultation with Natural England. Table 3 considers each relevant section of the draft GNLP Policy 2: Sustainable Communities Supplementary Planning Document (SPD) in relation to whether there is potential for a likely significant effect on protected Habitat sites. This constitutes Stage 1 Screening as set out under paragraph 3.1 above. Consideration is given to the characteristics and location of the protected sites. The relevant sections are considered within the context of the GNLP policy 2 from which it supplements, and which has itself been subject to Habitats Regulations Assessment, as set out in section 3.

#### 6. Conclusions and Statement of Reasons for Determination

- 6.1 The Policy 2: Sustainable Communities SPD (draft) does not introduce new policies or proposals outside the scope of the adopted Greater Norwich Local Plan (GNLP). Instead, it supplements policies in the GNLP by providing further detailed and specific guidance on how to address the ten key social, economic and environmental issues outlined in GNLP Policy 2. It also provides further guidance regarding the submission of Sustainability Statements, Health Impact Assessments, Delivery Plans and master-planning as required by the policy which has already been subject to HRA and SA/SEA.
- 6.2 The overall conclusions of the HRA undertaken for the adopted GNLP (supported by the results of the screening undertaken for the SPD in this document) state that the plan is not likely to have adverse effect on the integrity of the European sites (Natura 2000 and Ramsar site(s)), either alone or incombination with other plans or projects. Therefore further 'Appropriate Assessment as per stage 2 of the HRA is not considered necessary or required for the SPD.
- 6.3 Furthermore, in accordance with Part 2(9) of the Environmental Assessment of Plans and Programmes Regulations 2004 (as Amended including through EU exit legislation or SEA Regulations), Broadland District Council, Norwich City Council and South Norfolk Council, as the competent authorities consider that the Policy 2: Sustainable Communities (SPD) (draft) is unlikely to have any significant environmental effects that have not already been assessed as part of the Greater Norwich Local Plan. Therefore, the Councils consider that a Strategic Environmental Assessment is not required for this SPD.
- 6.4 The Council(s) have consulted on this screening opinion with Historic England, Natural England and the Environment Agency from 3 July until 8 August 2025 as per the HRA/ SEA regulations before the screening opinion is confirmed final. Therefore, this determination notice will be published on our website alongside the SPD consultation.
