

Norfolk County Council proposes to make a Temporary Traffic Regulation Order (the "Order") (CTRO1371) affecting the Whiffler Road from its junction with Boundary Road for 20 metres southwards ("Road A") and U57468 Boundary Road at its junction with A140 Boundary Road ("Road B") and A140 Boundary Road from its junction with Drayton High Road to its junction with City View Road ("Road C") in the City of Norwich to facilitate traffic signal replacement works, the Road A will be temporarily closed (except for pedestrian access) and traffic over Road B will be temporarily restricted from turning right onto A140 Boundary Road and the Road C will be temporarily subject to a 30 miles per hour speed restriction for the duration of the works/period the closure is necessary which is anticipated to be from 9<sup>th</sup> January to 5<sup>th</sup> February 2026, but may continue to be closed/restricted until the 5<sup>th</sup> August 2026 where the closure/restriction is still required beyond the anticipated dates.

Alternative route is via: A) Whiffler Road, Drayton Road, Boundary Road and vice versa B) Boundary Road, Reepham Road, Cromer Road and Boundary Road.

The works promoter for this restriction/closure is: Norfolk County Council.

Vehicular access will be permitted to a final destination in the Roads A-C where signs indicating such access is possible and permitted are in place.

The Order shall automatically revoke on the completion of the works/when the closure/restriction is no longer necessary or otherwise on the 5<sup>th</sup> August 2026 without further notice.

If necessary, the restriction could run for a maximum period of 18 months from the date the Order is effective.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/closure imposed by the Order shall be guilty of an offence.

Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.

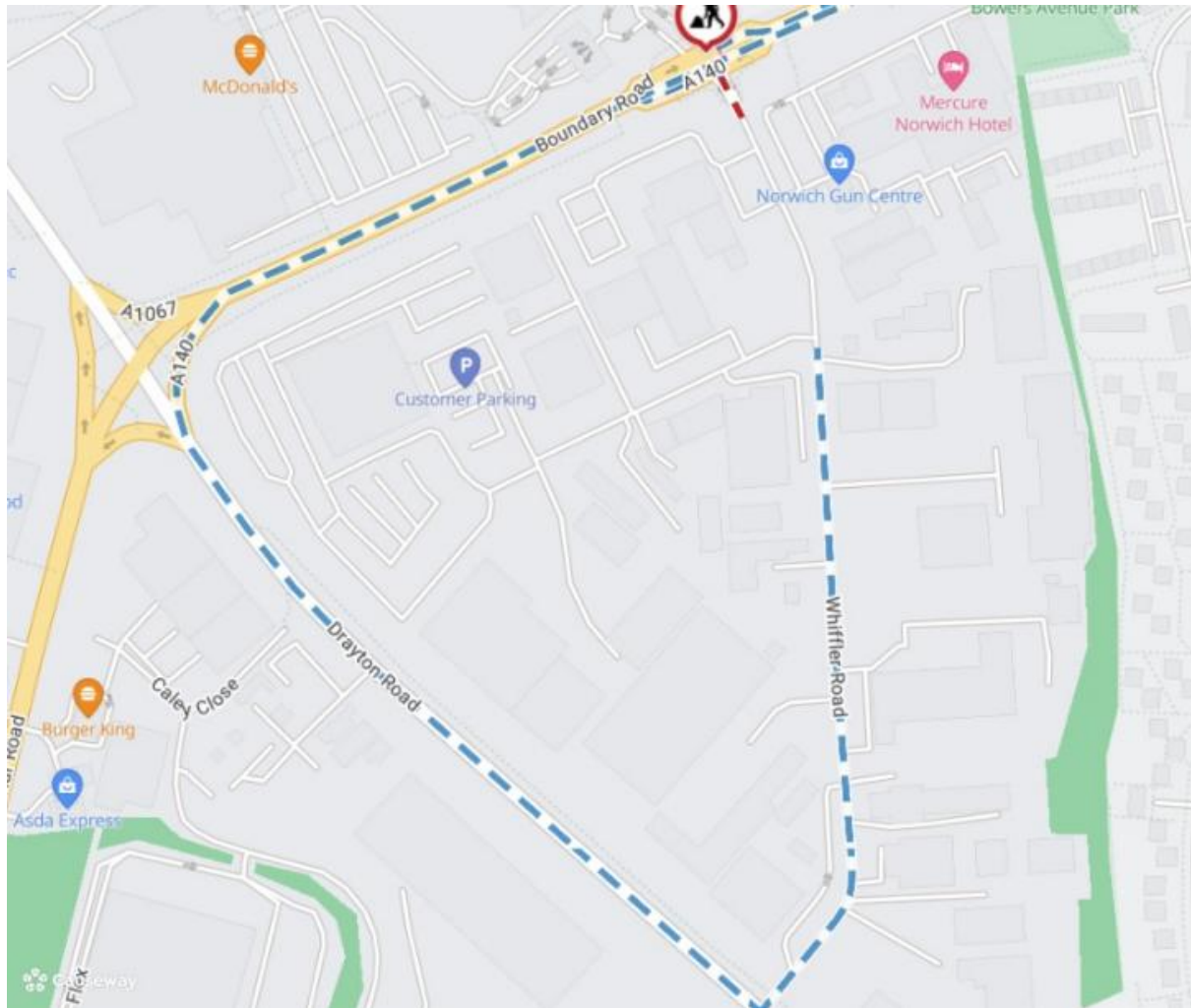
In the event of the start date being delayed the new start date will be displayed on site in advance.
