

**Norfolk County Council (Norwich, Ten Bells Lane)**  
**Emergency Notice**  
**Temporary Traffic Regulation Order 2026**  
**Section 14(2) of the Road Traffic Regulation Act 1984**

Norwich, Ten Bells Lane (CTRO1582) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to urgent leak repair works the use by vehicles (of any class) of the Ten Bell Lane from its junction with Pottergate to its junction with St Benedicts Street (the "Road") in the City of Norwich will be temporarily prohibited.

Alternative route is via: Pottergate, Cow Hill, Upper St Giles Street, Cleveland Road, Grapes Hill, St Swithins Road, Westwick Street, St Margarets Street.

The works promoter for this closure is: Anglian Water.

The closure is necessary because of the likelihood of danger to the public or serious damage to the Road or both.

The closure is anticipated to take place from 27<sup>th</sup> May to 2<sup>nd</sup> June 2026 but the Road may continue to be closed until the 16<sup>th</sup> June 2026 where the closure is still required beyond the anticipated dates.

This Notice shall automatically revoke on the completion of the works / when the closure is no longer necessary or otherwise on the 16<sup>th</sup> June 2026 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

Any existing restrictions or prohibitions within Orders made under the RTRA 1984 will become suspended where they conflict with the provisions of this Notice during the operation of this Notice.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the closure imposed by the Order shall be guilty of an offence.

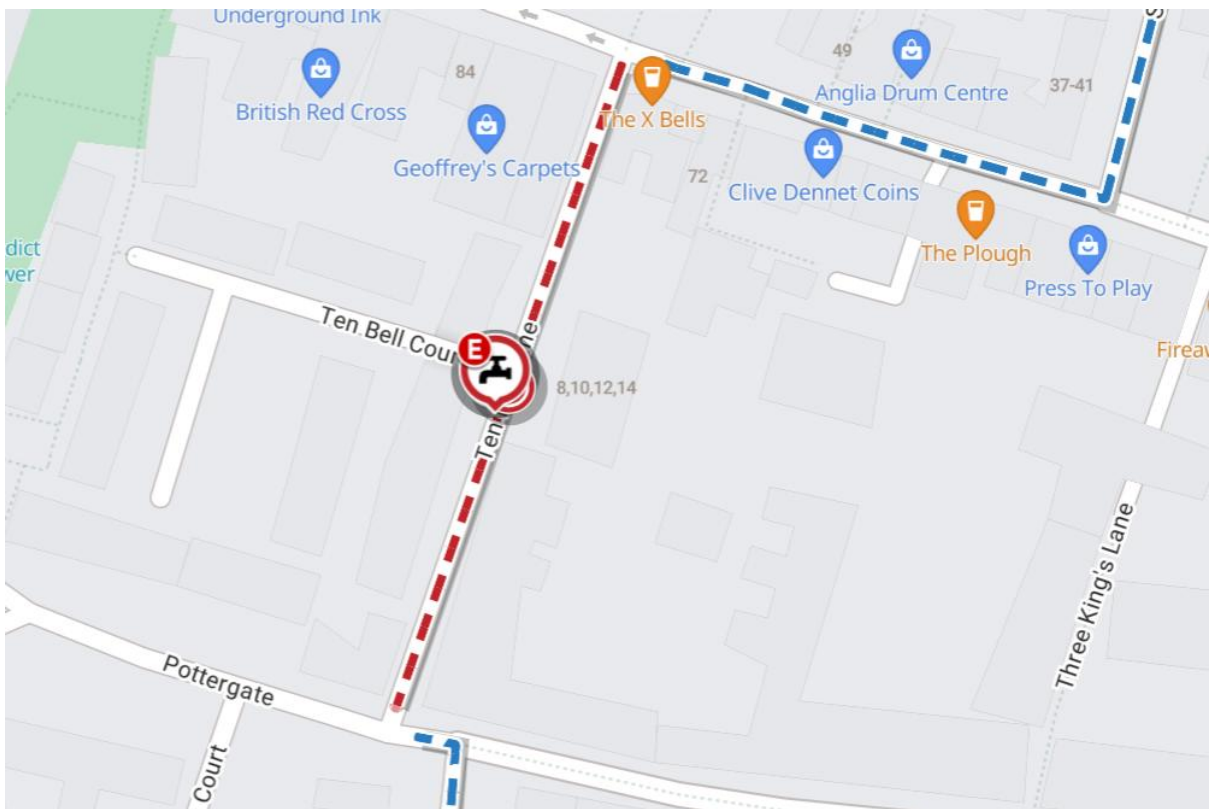
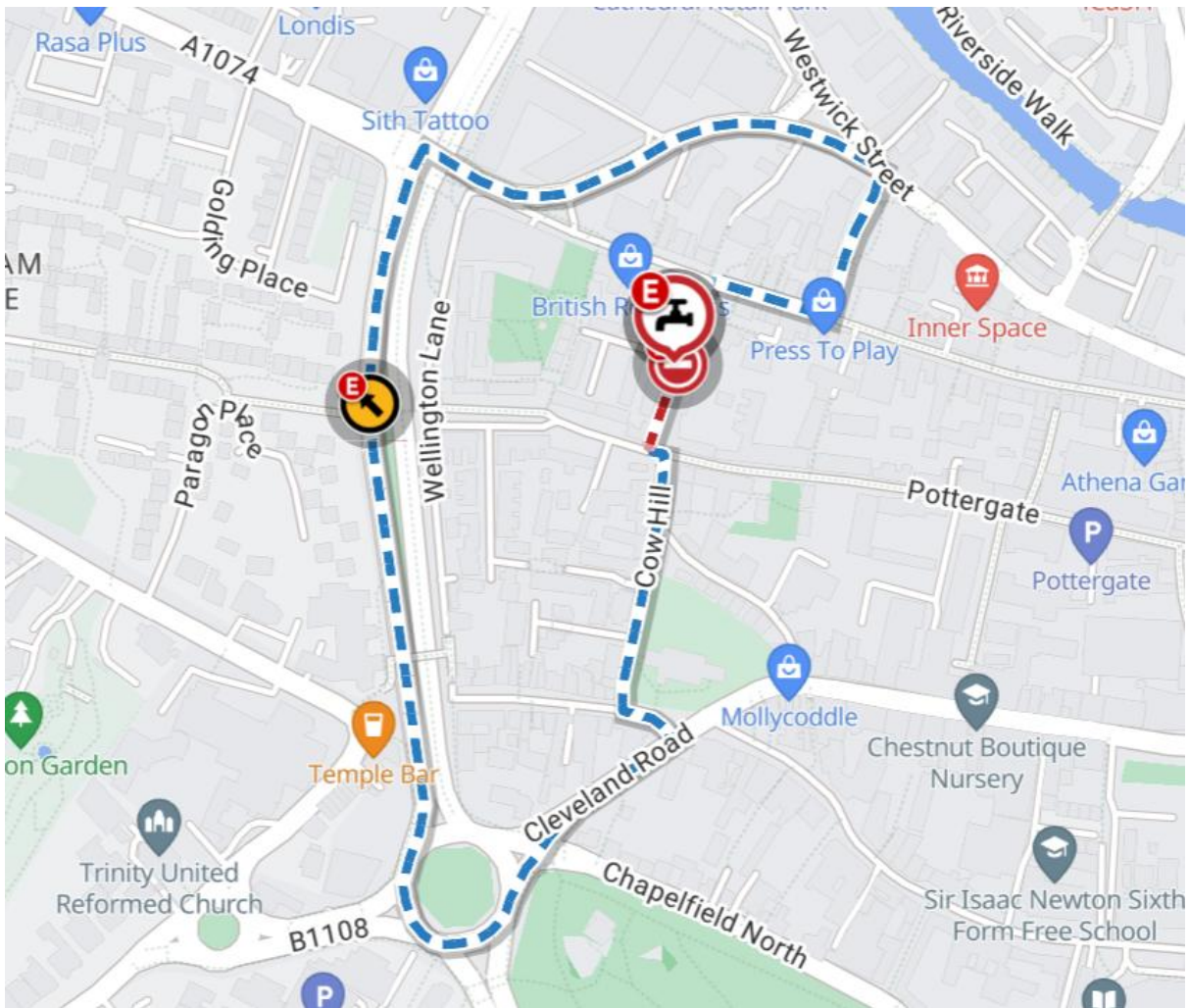
Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
