The premises will operate as a licensed pub offering the sale of alcohol, food, live music and background recorded music. CCTV will operate throughout the premises, Challenge 25 will be enforced, and staff will be trained in responsible alcohol sales. The premises will promote all four licensing objectives.

b). The prevention of crime and disorder

A comprehensive CCTV system will cover all key areas of the premises, with recordings retained for at least 31 days. Staff will be trained in responsible alcohol sales and conflict management. SIA door supervisors will be employed when required, and an incident log will be maintained and made available to authorities upon request.

c). Public safety

The premises will comply with all fire safety regulations and health and safety requirements. Fire alarms and fire extinguishers are installed throughout the building on each floor. Staff will be trained in emergency procedures including evacuation procedures. The premises will be maintained in a safe condition for customers and staff.

d). The prevention of public nuisance

Recorded and live music will be played indoors at appropriate volumes to minimise noise disturbance. Doors and windows will remain closed during entertainment except for access and egress. Customers using the smoking area will be monitored, and clear signage will ask patrons to leave the premises quietly and respect nearby residents.

e). The protection of children from harm

The premises will operate a Challenge 25 policy. Customers who appear under 25 will be required to provide valid photographic identification before purchasing alcohol. Staff will receive age verification training, refusals will be recorded in a refusals log, and management will regularly review compliance procedures.
