

Norfolk County Council (Norwich, Cambridge Street)
Emergency Notice
Temporary Traffic Regulation Order 2026
Section 14(2) of the Road Traffic Regulation Act 1984

Norwich, Cambridge Street (2184-3678-0659-5244) Notice

In accordance with the provisions of Section 14(2) of the Road Traffic Regulation Act 1984, the Norfolk County Council HEREBY GIVE NOTICE that owing to a gas leak the use by vehicles (of any class) of Cambridge Street from 2 metres east of its junction with Unthank Road for 10 metres eastwards ("Road A") and Cambridge Street from 12 metres east of its junction with unthank road for 468 metres eastwards ("Road B") in the City of Norwich will be temporarily prohibited/restricted. Traffic (constituting any class of vehicle) over Road A shall be temporarily prohibited and traffic (constituting any class of vehicle) over Road B shall be temporarily subject to the suspension of the one-way system (eastbound) to allow vehicles to travel in both a westwards and eastwards direction.

Alternative route is via: Brunswick Road, Newmarket Street, Gloucester Street, Unthank Road and vice versa.

The works promoter for this restriction/closure is: Cadent.

The closure/restriction is necessary because of the likelihood of danger to the public or serious damage to the Road or both.

The closure/restriction is anticipated to take place from 28th August to 8th September 2026, but the Road may continue to be closed/restricted until the 17th September 2026 where the closure/restriction is still required beyond the anticipated dates.

This Notice shall automatically revoke on the completion of the works / when the closure/restriction is no longer necessary or otherwise on the 17th September 2026 without further notice.

If necessary, this Notice may be extended for an additional 21 days by further Notice and/or for a maximum of 18 months from the date this Notice is effective by further Order.

Any existing restrictions or prohibitions within Orders made under the RTRA 1984 will become suspended where they conflict with the provisions of this Notice during the operation of this Notice.

A person who contravenes, or who uses or permits the use of a vehicle in contravention of the restriction/ closure imposed by the Order shall be guilty of an offence.

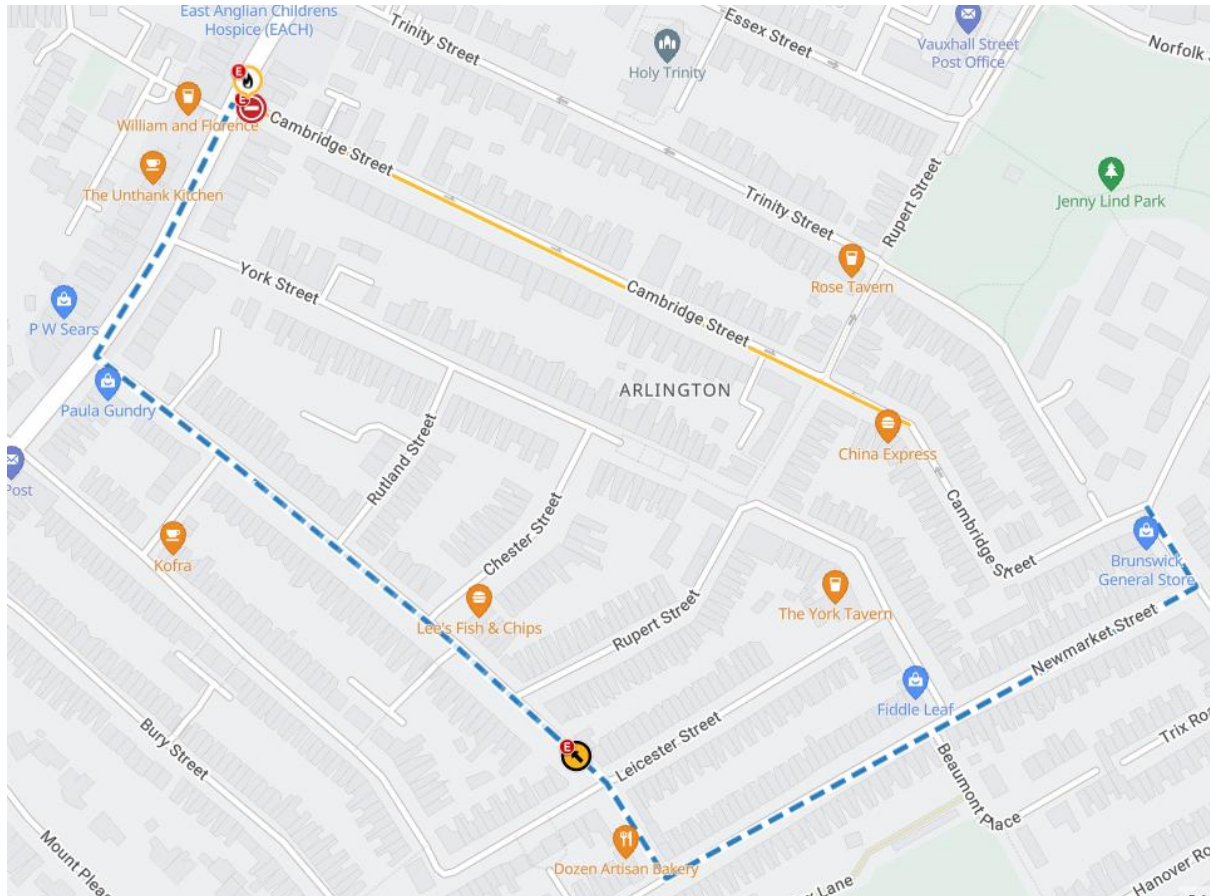
Penalty: £1000 maximum fine on conviction and/or endorsement for contravention.
